AN ORDINANCE BY

COUNCILMEMBER ALEX WAN

TO AMEND ORDINANCE 11-O-1169, WHICH CALLED AN ELECTION TO BE HELD ON NOVEMBER 8, 2011 FOR THE PURPOSE OF SUBMITTING THE QUESTION OF SUNDAY PACKAGE ALCOHOL SALES BY RETAILERS OF MALT BEVERAGES, WINE AND DISTILLED SPIRITS BETWEEN THE HOURS OF 12:30 P.M. AND 11:30 P.M. TO THE ELECTORS FOR APPROVAL OR REJECTION ON NOVEMBER 8, 2011, IN ORDER TO SPECIFY THAT IF MORE THAN ONE-HALF OF THE VOTES CAST BY THE ELECTORS ON THIS QUESTION ARE FOR APPROVAL OF SUNDAY PACKAGE SALES, THAT SUCH SALES SHALL BECOME EFFECTIVE ON JANUARY 1, 2012; TO RATIFY ANY ACTIONS TAKEN BY THE CITY OF ATLANTA PURSUANT TO ORDINANCE 11-O-1169 AND SUBSEQUENT TO THE APPROVAL THEREOF; AND FOR OTHER PURPOSES.

WHEREAS, the Georgia General Assembly passed Senate Bill 10 during the 2011 Legislative Session which authorizes counties and municipalities to permit the sale by retailers of malt beverages, wine and distilled spirits on Sundays, if approved by referendum; and

WHEREAS, the Atlanta City Council adopted Ordinance No. 11-O-1169 on September 6, 2011 which authorized the calling of an election to be held on November 8, 2011 for the purpose of submitting the question of Sunday package sales to the electors of the City of Atlanta for approval or rejection; and


WHEREAS, Ordinance No. 11-O-1169 was approved by operation of law on September 15, 2011; and

WHEREAS, Ordinance No. 11-O-1169 did not specify the date on which Sunday package sales shall become effective if more than one-half of the votes cast by the electors on the question of Sunday package sales are for approval of such; and

WHEREAS, it is the desire of the City of Atlanta that Ordinance No. 11-O-1169 be amended in order to specify that Sunday package sales, if approved by the electors on November 8, 2011, shall be effective on January 1, 2012.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

SECTION 1. That Ordinance 11-O-1169, which authorized the calling of an election to be held on November 8, 2011 for the purpose of submitting the question of Sunday package



alcohol sales by retailers of malt beverages, wine, and distilled spirits to the electors of the City of Atlanta for approval or rejection, shall be amended in order to specify that if more than one-half of the votes cast by the electors on the question of Sunday package sales are for approval, that such sales shall be authorized between the hours of 12:30 p.m. and 11:30 p.m. effective January 1, 2012.

SECTION 2. That all actions taken by the City of Atlanta pursuant to Ordinance 11-O-1169 and subsequent to the approval thereof, are hereby ratified.

SECTION 3. That the amendment and ratification in this ordinance shall become effective immediately upon approval.

SECTION 4. That all ordinances and parts of ordinances in conflict herewith are hereby waived to the extent of the conflict.
