**AN ORDINANCE
BY COUNCILMEMBER KWANZA HALL**

**AUTHORIZING THE MAYOR OR HIS DESIGNEE
TO REMOVE THE LEFT TURN RESTRICTION TO
PERMIT A LEFT TURN FROM THE CLOSEST
SOUTHBOUND LANE OF PEACHTREE STREET
SW ONTO UPPER ALABAMA ST SW; AND FOR
OTHER PURPOSES.**

WHEREAS, the opening of the Comfort Suites on the corner of Peachtree Street and Alabama Street earlier this year included a valet parking service for the hotel; and

WHEREAS, Upper Alabama St SW is not open to through traffic and;

WHEREAS, guests travelling south on Peachtree Street currently cannot access the hotel's valet service without turning left illegally or driving around the block to head north on Peachtree and turn right onto Upper Alabama; and

WHEREAS, there is desire by the Atlanta City Council to facilitate the movement of traffic from southbound Peachtree Street to the Comfort Suites on Upper Alabama Street; and

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA as follows:

SECTION 1: That the Mayor or his designee is authorized to remove the left turn restriction to permit a left turn from the closest southbound lane of Peachtree Street S.W. onto Upper Alabama St S.W.

SECTION 2: That the Mayor or his designee is further authorized to install and replace signage as appropriate.

SECTION 3: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived in this instance only.
