A SUBSTITUTE RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE RENEWAL AGREEMENT NO. 1 FOR CONTRACT NO. FC-6006007882; NOISE INSULATION PROGRAM, WITH THC, INC., IN THE AMOUNT NOT TO EXCEED \$4,500,000, TO PROVIDE CONTINUED NOISE INSULATION PROGRAM SERVICES FOR THE DEPARTMENT OF AVIATION ON A TASK ORDER BASIS; ALL SERVICES WILL BE CHARGED TO AND PAID FROM PTAE0: 18100312 (NOISE LAND RESERVE) 105 (TASK) 550231261 (DOA R N E AYH0) 5212001 (CONSULTING/PROFESSIONAL SERV) AND FDOA: 5502 (AIRPORT RNE) 180201 (DOA AVIATION CAPITAL PLANNING & DEVELOPMENT) 5212001 (CONSULTING/PROFESSIONAL SERV) 7563000 (AIRPORT) 100312 (NOISE LAND RESERVE) 31261 (DOA R N E AYH0); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) executed Contract No. FC-6006007882 (“Contract”); Noise Insulation Program, dated November 17, 2008, with THC, Inc. (“THC”), to provide aircraft noise mitigation measures to eligible structures on a task order basis, pursuant to Resolution 08-R-1581; and

WHEREAS, the Contract was for an initial term of three years with two one-year renewal options which may be exercised solely at the City’s discretion. The initial term is due to expire on November 16, 2011; and

WHEREAS, the Aviation General Manager and the Chief Procurement Officer have reviewed THC’s performance under the Contract and have recommended that the Contract be renewed for an additional year; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA GEORGIA, that the Mayor is authorized to execute Renewal Agreement No. 1 with THC for an additional one-year period commencing effective February 15, 2012, in an amount not to exceed \$4,500,000.

BE IT FURTHER RESOLVED, that all contracted services will be charged to and paid from PTAE0: 18100312 (Noise Land Reserve) 105 (Task) 550231261 (DOA R N E AYH0) 5212001 (Consulting/Professional Serv) and FDOA: 5502 (Airport RNE) 180201 (DOA Aviation Capital Planning & Development) 5212001 (Consulting/Professional Serv) 7563000 (Airport) 100312 (Noise Land Reserve) 31261 (DOA R N E AYH0).



BE IT FURTHER RESOLVED, that the City Attorney is hereby directed to prepare an appropriate Renewal Agreement.

BE IT FINALLY RESOLVED, that the Renewal Agreement will not become binding on the City and the City will incur no liability or obligation under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved by the City Attorney as to form and delivered to THC.
