A RESOLUTION

BY COUNCILMEMBERS ALEX WAN AND JOYCE M. SHEPERD

A RESOLUTION TO AMEND RESOLUTION 11-R-0770 SO AS TO EXTEND THE EXPIRATION DATE FOR THE TIRE COMMISSION; AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta City Council adopted on May 16, 2011, the attached Resolution 11-R-0770 to create a Tire Commission to study ways to manage illegal tire dumping, increase the city's code enforcement and suggest language to amend the existing City Code; and

WHEREAS, the Tire Commission has started the dialogue with meetings focusing on illegal tire dumping control and prevention; and

WHEREAS, the Commission has received suggestions from members and citizens and studies from University of Georgia and Spelman College; and

WHEREAS, the Commission needs additional time to continue the discussion and to complete the report with recommendations to the Mayor and City Council; and

WHEREAS, the Atlanta City Council wishes to extend the expiration date for the Tire Commission from September 30, 2011, to December 31, 2011.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That Section 4 in Resolution 11-R-0770 is hereby amended to read as follows:

"SECTION 4: That the Commission shall present a study with recommendations via a report to the Mayor and City Council no later than **December 31, 2011**, effectively ending the duty of the Commission."

SECTION 2: All resolutions and parts of resolutions in conflict herewith are hereby repealed for purposes of the resolutions only, and only to the extent of the conflict.
