

A RESOLUTION AUTHORIZING THE DEPARTMENT OF PUBLIC WORKS TRANSPORTATION SERVICES OF THE CITY OF ATLANTA TO ASSIST THE CITIZENS OF HISTORIC BROOKHAVEN IN THE PLACEMENT OF NEIGHBORHOOD IDENTIFICATION SIGNS WITHIN THE THEIR NEIGHBORHOOD, WHICH IS BOUNDED BY WINDSOR PARKWAY TO THE NORTH, PEACHTREE DUNWOODY ROAD TO THE WEST, MABRY DRIVE TO THE EAST, AND PEACHTREE ROAD TO THE SOUTH; AND FOR OTHER PURPOSES.

WHEREAS, the citizens of Historic Brookhaven have expressed their desire to identify their neighborhood in an attractive, welcoming, and unique manner; and

WHEREAS, the citizens of Historic Brookhaven have contacted the City of Atlanta to determine the means which Inman Park obtained its neighborhood identification signs; and

WHEREAS, the citizens of Historic Brookhaven have expressed their interest to have similar signs installed in their neighborhood, which, is bounded by Windsor Parkway to the North, Peachtree Dunwoody Road to the West, Mabry Drive to the East, and Peachtree Road to the South.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Department of Public Works/Transportation Services will assist the Historic Brookhaven Neighborhood Association in their acquisition and installation of neighborhood identification signs.

SECTION 2: That the Historic Brookhaven Neighborhood Association will be responsible for costs involved in acquiring, installing and maintaining the signs.

SECTION 3: That any signs that are allowed under this project will be consistent with the Department of Public Works' identification signs to ensure uniformity in regards to shape, size, and color.

SECTION 4: That the Historic Brookhaven Neighborhood Association shall agree in writing to indemnify and hold the City of Atlanta harmless from any and all claims arising out of the acquisition, installation, use, or maintenance of the signs.

SECTION 5: That the Commissioner of Public Works or his designee is hereby authorized to accept the agreement to indemnify and hold harmless in the City's behalf.
