**A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT FOR PROJECT NUMBER FC-5272A, CONTRACT FOR EMERGENCY SERVICES ON CALL RESPONSE, WITH CERES ENVIRONMENTAL SERVICES, INC. TO PROVIDE, AS NEEDED, ON CALL EMERGENCY SERVICES FOR THE DEPARTMENT OF PUBLIC WORKS ON AN EMERGENCY BASIS; ALL SERVICES TO BE PAID FROM FDOA: 1001 (GENERAL FUND) 130302 (DPW TRAFFIC ENGINEERING) 5222002 (REPAIR AND MAINTENANCE) 3920000 (EMERGENCY MANAGEMENT); AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta ("City") did solicit a Request for Proposals from qualified firms for Project Number FC-5272A, Contract for Emergency Services on Call Response ("Contract"), on behalf of the City's Department of Public Works; and

**WHEREAS**, after review and evaluating the Proponent's qualifications, the Commissioner of the Department of Public Works and the Chief Procurement Officer recommend the award of the Contract to Ceres Environmental Services, Inc.

**THE CITY COUNCIL OF THE CITY OF ATLANTA HEREBY RESOLVES** that the Mayor is authorized to execute on behalf of the City of Atlanta, Contract Number FC-5272A, Contract for Emergency Services on Call Response, for the initial term of the Agreement, which shall be funded annually on an emergency basis.

**BE IT FURTHER RESOLVED**, that the term of the Contract will be for a period of one (1) year, with two (2) one (1) year renewal options at the sole discretion of the City.

**BE IT FURTHER RESOLVED**, that all contracted work will be charged to and paid from FDOA: 1001 (General Fund) 130302 (DPW Traffic Engineering) 5222002 (Repair and Maintenance) 4270000 (Traffic Engineering).

**BE IT FURTHER RESOLVED**, that the City Attorney is hereby directed to prepare the appropriate Contract for execution by the Mayor.

**BE IT FURTHER RESOLVED**, that the Department of Public Works is authorized during the term of the Contract, including any renewal terms to issue Emergency Task Orders for emergency services.

**BE IT FINALLY RESOLVED**, that the Contract will not become binding on the City and the City will incur no liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved by the City Attorney as to form and delivered to Ceres Environmental Services, Inc.
