


**A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO PARTICIPATE WITH THE ATLANTA DOWNTOWN IMPROVEMENT DISTRICT IN MAKING CERTAIN IMPROVEMENTS TO WOODRUFF PARK BY PROVIDING AN AMOUNT NOT TO EXCEED TWENTY THOUSAND DOLLARS (\$20,000.00) TO BE USED TOWARD SITE PREPARATION OF A PLAYGROUND, WHERE ALL FUNDS SHALL BE CHARGED TO AND PAID FROM FUND, DEPARTMENT, ORGANIZATION AND ACCOUNT NUMBERS: 3501 (PARK IMPROVEMENT FUND) 140106 (PARK DESIGN) 5222003 (REPAIR & MAINTENANCE OTHER) 6220000 (PARK AREAS); AND FOR OTHER PURPOSES.**

**WHEREAS, Woodruff Park ("Park") is a 6 acre park located in the heart of downtown Atlanta, Georgia, owned by the City of Atlanta ("City"); and**

**WHEREAS, the Park is named after Robert W. Woodruff who donated the land to the City; and**

**WHEREAS, the Atlanta Downtown Improvement District ("ADID"), founded in 1995 by Central Atlanta Progress, is a public-private partnership that strives to create a livable environment for Downtown Atlanta; and**

**WHEREAS, ADID has approached the City to install a safe, long-lasting and unique playground at the Park ("Project"); and**

**WHEREAS, ADID has raised Forty Five Thousand Dollars (\$45,000.00) towards the Project; and**


**WHEREAS, the Department of Parks, Recreation and Cultural Affairs desires to participate in the Project by providing funds to ADID for site preparation in an amount not to exceed Twenty Thousand Dollars (\$20,000.00); and**

**WHEREAS, the City is appreciative of the contributions of ADID and finds that it is in the City's best interest to assist ADID in completing this Project.**

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor or his designee, on behalf of the City, is hereby authorized to provide funds in an amount not to exceed Twenty Thousand Dollars (\$20,000.00) to the Atlanta Downtown Improvement District to be used toward the construction of the Project at the Park.**

**BE IT FURTHER RESOLVED, that the City hereby accepts the contributions of the Atlanta Downtown Improvement District.**

**BE IT FINALLY RESOLVED, that all funds shall be charged to and paid from the following Fund, Department, Organization, and Account Numbers: 3501 (Park Improvement Fund) 140106 (Park Design) 5222003 (Repair & Maintenance Other) 6220000 (Park Areas).**
