AMOUNT NOT TO EXCEED \$5,072,233.00; TO BE CHARGED
TO AND PAID FROM FDOA 5501 (AIRPORT REVENUE FUND)
180312 (DOA AVIATION OPERATIONS) 5212001
(CONSULTING/PROFESSIONAL SERVICES) 7563000
(AIRPORT); AND FOR OTHER PURPOSES.**

WHEREAS, the City of Atlanta (the “City”) owns and operates Hartsfield-Jackson Atlanta International Airport (the “Airport”); and

WHEREAS, the City entered into an agreement with Air Serv Facility Services, Inc., dba ICS Contract Services (“ICS”), as the contractor for the Quality Customer Care at Hartsfield-Jackson Atlanta International Airport on January 14, 2009; and

WHEREAS, the agreement has an initial term of three (3) years, and includes one (1) two (2) year renewal option at the sole discretion of the City; and

WHEREAS, the initial term of the contract will expire on January 13, 2012; and

WHEREAS, ICS has performed the contract services satisfactorily; and

WHEREAS, the Chief Procurement Officer and the Aviation General Manager recommend the execution of the renewal agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor is hereby authorized to execute a renewal agreement for FC-4540, Quality Customer Care at Hartsfield-Jackson Atlanta International Airport with Air Serv Facility Services, Inc., dba ICS Contract Services, in an amount not to exceed \$5,072,233.00.

BE IT FURTHER RESOLVED, that the renewal term will be for two (2) years and shall commence on January 14, 2012 and shall continue through January 13, 2014, in an amount not to exceed \$5,072,233, with payments to be made as follows:

- \$ 572,233 from January 14, 2012 through June 30, 2012
- \$3,000,000 from July 1, 2012 through June 30, 2013
- \$1,500,000 from July 1, 2013 through January 13, 2014



BE IT FURTHER RESOLVED, that all contracted work will be charged to and paid from FDOA 5501 (Airport Revenue Fund) 180312 (DOA Aviation Operations) 5212001 (Consulting/Professional Services) 7563000 (Airport).

BE IT FURTHER RESOLVED, that the City Attorney is directed to prepare an appropriate renewal agreement for execution by the Mayor, to be approved as to form by the City Attorney

BE IT FINALLY RESOLVED, that said Amendment shall not become binding upon the City and the City shall incur no liability upon it until such Amendment has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney and delivered to Air Serv Facility Services, Inc., dba ICS Contract Services.
