


OF THE CITY OF ATLANTA CODE OF ORDINANCES, UTILIZING GENERAL SERVICES ADMINISTRATION CONTRACT NUMBER GS-35F-0692P WITH EVERBRIDGE, INCORPORATED FOR THE PURCHASE OF COA-5505-PL: EVERBRIDGE AWARE INCIDENT NOTIFICATION SOLUTION FOR THREE (3) YEARS WITH TWO (2) ONE-YEAR RENEWAL OPTIONS IN AN AMOUNT NOT TO EXCEED SIXTY-TWO THOUSAND DOLLARS AND NO CENTS (\$62,000.00) PER YEAR FOR A TOTAL CONTRACT AMOUNT NOT TO EXCEED ONE HUNDRED EIGHTY-SIX THOUSAND DOLLARS (\$186,000.00) TO BE CHARGED TO AND PAID FROM FUND, DEPARTMENT, ORGANIZATION AND ACCOUNT NUMBERS: 2151 (EMERGENCY TELEPHONE SYSTEM) 240207 (APD E911) 5213001 (CONSULTING /PROFESSIONAL SERVICES – TECHNICAL) 3800000 (ACTIVITY) ; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) has a need for an emergency notification system to communicate with the public anywhere, anytime, and via any communication method (i.e. Landline, mobile, email, text, pager, fax); and

WHEREAS, the City has identified the Everbridge Aware Incident Notification Solution as a tool that will address those needs; and

WHEREAS, the total cost of Everbridge Aware Incident Notification Solution is Sixty-Two Thousand Dollars And No Cents (\$62,000.00) per year; and

WHEREAS, pursuant to Article X, Division 15 Intergovernmental Relations of the City of Atlanta Code of Ordinances, the Chief Procurement Officer may procure supplies, services or construction items through contracts established by a public procurement unit outside the City; and

WHEREAS, the Chief Information Officer and the Chief Procurement Officer recommend utilizing General Services Administration (“GSA”) contract number GS-35F-0692P with Everbridge, Inc. to purchase the COA-5505-PL: Everbridge Aware Incident Notification Solution for three (3) years with (2) one-year renewal options; and

WHEREAS, this cooperative agreement was competitively procured in a manner consistent with Division 4 of the City’s Procurement Code, and the cost of the goods and/or services are comparable; and

WHEREAS, the Chief Information Officer and the Chief Procurement Officer recommend utilizing GSA contract number GS-35F-0692P with Everbridge Inc. to purchase COA-5505-PL: Everbridge Aware Incident Notification Solution for three (3) years with two (2) one-year



renewal options on behalf of the Department of Information Technology, in an amount not to exceed \$62,000.00 the first year (FY12), \$62,000.00 the second year (FY13) and \$62,000.00 the third year (FY14) for a total Software and Maintenance agreement amount not to exceed One Hundred Eighty-Six Thousand Dollars (\$186,000.00).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor is authorized to enter into a cooperative purchasing agreement with Everbridge, Inc. utilizing GSA contract number GS-35F-0692P to purchase COA-5505-PL: Everbridge Aware Incident Notification Solution for three (3) years with two (2) one-year renewal options effective December 1, 2011 in an amount not to exceed in an amount not to exceed \$62,000.00 the first year (FY12), \$62,000.00 the second year (FY13) and \$62,000.00 the third year (FY14) for a total Software and Maintenance agreement amount not to exceed One Hundred Eighty-Six Thousand Dollars (\$186,000.00) to be charged to and paid from the Fund, Department, Organization, and Account Numbers: 2151 (Emergency Telephone System) 240207 (APD E911) 5213001 (Consulting /Professional Services – Technical) 3800000 (Activity)and for other purposes.

BE IT FURTHER RESOLVED, that the Chief Procurement Officer in consultation with the City Attorney is directed to prepare the appropriate Agreement for execution by the Mayor.

BE IT FINALLY RESOLVED, that the Agreement will not become binding upon the City, and the City shall incur no liability upon same until contract has been approved by the City Attorney as to form, executed by the Mayor, attested to by the Municipal Clerk, and delivered to the contracting parties.
