**AN ORDINANCE AMENDING THE FY 2012 (AIRPORT RENEWAL AND EXTENSION FUND) BUDGET BY TRANSFERRING TO AND FROM APPROPRIATIONS IN THE AMOUNT OF \$50,000.00 TO PROVIDE ADEQUATE FUNDING FOR ACQUISITION OF A POLICE K-9 TRUCK FOR USE AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta owns and operates Hartsfield-Jackson Atlanta International Airport (“Airport”); and

**WHEREAS**, the City of Atlanta is required under various Airport Lease Agreements to provide a level of police protection at the Airport; and

**WHEREAS**, the Department of Aviation funds City Airport Police Services at Hartsfield – Jackson Atlanta International Airport; and

**WHEREAS**, the City of Atlanta Police Department incurred a loss of one of its K-9 vehicles that serviced the Airport in an accident last year and now needs to be replaced for services required at the Airport; and

**WHEREAS**, it is now necessary to amend the Fiscal Year 2012 Airport Renewal & Extension Fund Budget to adequately fund the acquisition of a Police K-9 Truck for use at Hartsfield-Jackson Atlanta International Airport.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS** as follows:

**Section 1:** That the Fiscal Year 2012 (Airport Renewal and Extension Fund) Budget be and hereby is amended as follows:
