


**A RESOLUTION AUTHORIZING THE SETTLEMENT AND PAYMENT OF ALL CLAIMS FOR COMPENSATION IN AN AMOUNT TO BE DETERMINED, TO THE FOLLOWING CITY OF ATLANTA PARKING ENFORCEMENT OFFICERS WHO ALLEGE THAT THE CITY WRONGFULLY TERMINATED THEIR EMPLOYMENT BY FAILING TO FOLLOW ITS ORDINANCES AND PROCEDURES GOVERNING REDUCTION IN FORCE (RIF): LAMAR J. SINGLETON, BOBBY ASBURY, TINA NEALOUS, KAREEMA AZIZ, WAYNE NORRIS, SHORONDA WILLIAMS AND DADRIKO LINDSEY; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO DISTRIBUTE THE SETTLEMENT AMOUNT; AND FOR OTHER PURPOSES.**

**WHEREAS**, Lamar J. Singleton, Bobby Asbury, Tina Nealous, Kareema Aziz, Wayne Norris, Shoronda Williams and Dadriko Lindsey, all former City of Atlanta parking enforcement officers, allege that their employment was wrongfully terminated by the city's failure to follow its ordinances and procedures governing reduction in force (RIF), upon the city entering into the parking contract with Park Atlanta Inc.; and

**WHEREAS**, the City Attorney, pursuant to Resolution 11-R-0433, has recommended the settlement of all claims for eight other former parking enforcement officers who have made the same or similar claim; and

**WHEREAS**, it is only just and fair that all of the former parking enforcement officers be treated equally.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:**

**SECTION 1:** The City of Atlanta is hereby authorized to settle and pay all claims for compensation in an amount to be determined, to Lamar J. Singleton, Bobby Asbury, Tina Nealous, Kareema Aziz, Wayne Norris, Shoronda Williams and Dadriko Lindsey, all former City of Atlanta parking enforcement officers.

**SECTION 2:** The Chief Financial Officer is hereby authorized to make payment, in amounts to be determined, to Lamar J. Singleton, Bobby Asbury, Tina Nealous, Kareema Aziz, Wayne Norris, Shoronda Williams and Dadriko Lindsey, all former City of Atlanta parking enforcement officers, for the purpose of settling all claims against the City of Atlanta in connection with their alleged wrongful termination. Said payments shall be charged to and paid from the following fund, account and center numbers:
