



CITY OF ATLANTA, CIVIL ACTION FILE NO. 2010CV183496, PENDING IN FULTON COUNTY SUPERIOR COURT, IN THE AMOUNT OF \$5,000.00; AUTHORIZING SAID PAYMENT TO BE CHARGED TO AND PAID FROM FUND 1001 CENTER NUMBER 200101 (NON-DEPARTMENTAL) ACCOUNT 5212005 (LITIGATION EXPENSES) FUNCTIONAL ACTIVITY NUMBER 1512000 (ACCOUNTING); AUTHORIZING THE CHIEF FINANCIAL OFFICER TO DISTRIBUTE THE SETTLEMENT AMOUNT; AND FOR OTHER PURPOSES.

WHEREAS, NICOLE JOHNSON INDIVIDUALLY and as PARENT and next friend of BRIANNA LANE JOHNSON v. CITY OF ATLANTA, is a case involving alleged serious injuries resulting from a vehicle accident that occurred on or about March 31, 2010, when a City of Atlanta Police vehicle driven by Officer Robert Firkin, collided with the vehicle in which Brianna Lane Johnson was a;

WHEREAS, Plaintiff alleges that she suffered permanent injuries and scarring as a result of the auto accident with City of Atlanta Police Officer, who allegedly was operating a motor vehicle in a negligent manner;

WHEREAS, Plaintiff sought monetary damages for the injuries she incurred as well as attorney's fees and costs of litigation;

WHEREAS, Plaintiff has agreed to accept \$5,000.00, in full settlement of all claims against the City of Atlanta, which includes attorney's fees and costs of litigation;

WHEREAS, the City Attorney has done extensive review of the facts and the law and has determined that the City's potential financial exposure in defending Plaintiff's claims is in excess of the settlement amount.

WHEREAS, the City Attorney considers it to be in the best interest of the City to pay the amount of \$5,000.00 to settle all claims against the City of Atlanta.

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA hereby resolves as follows:

SECTION 1. The City Attorney is hereby authorized to settle and execute all documents in the case of NICOLE JOHNSON INDIVIDUALLY and as PARENT and next friend of BRIANNA LANE JOHNSON v. CITY OF ATLANTA in the amount of Five Thousand Dollars and no Cents (\$5,000.00).


