A RESOLUTION ON BEHALF OF THE DEPARTMENT OF AVIATION AUTHORIZING THE MAYOR TO AWARD AND EXECUTE CONCESSIONS AGREEMENT FC-5181; SLEEP UNIT SERVICES – CONCOURSES T AND F AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) owns and operates Hartsfield-Jackson Atlanta International Airport (“Airport”); and

WHEREAS, the City issued Request for Proposals FC-5181; Sleep Unit Services – Concourses T and F at Hartsfield-Jackson Atlanta International Airport and thereby solicited proposals for qualified concessionaires to provide sleep unit concessions services on Concourses T and F of the Airport; and

WHEREAS, one (1) responsive proposal was submitted in response to the solicitation; and

WHEREAS, based on a review by the Department of Aviation evaluation team, the Aviation General Manager and the Chief of Procurement Officer have recommended that Concessions Agreement FC-5181; Sleep Unit Services – Concourses T and F at Hartsfield-Jackson Atlanta International Airport (“the Agreement”) be awarded to Sojesma Atlanta, LLC.

WHEREAS, the Agreement will have an initial term of seven (7) years, with a single option to renew for an additional three (3) years, to be exercised at the City’s sole discretion

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor is authorized to award and execute the Agreement with Sojesma Atlanta, LLC for FC-5181, Sleep Unit Services-Concourses T and F.

BE IT FURTHER RESOLVED, that the Agreement will have an initial term of seven (7) years, with a single option to renew for an additional three (3) years, to be exercised at the City’s sole discretion

BE IT FURTHER RESOLVED, that the City Attorney is directed to prepare the Agreement for execution by the Mayor, with the same to be approved as to form by the City Attorney.

BE IT FINALLY RESOLVED, that the agreement will not become binding on the City and the City will incur no liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney and delivered to Sojesma Atlanta LLC.
