AUTHORIZING THE MAYOR TO EXECUTE CONCESSIONS
AGREEMENT FC-5215; BUSINESS AND ENTERTAINMENT AT
HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT WITH
BUSINESS TRAVELER SERVICES, INC.; AND FOR OTHER PURPOSES**

WHEREAS, the City of Atlanta (“City”), owns and operates Hartsfield-Jackson Atlanta International Airport (“the Airport”) and

WHEREAS, the City issued Request for Proposals FC-5215; Business and Entertainment at Hartsfield-Jackson Atlanta International Airport and thereby solicited proposals for qualified concessionaires to provide business and entertainment concessions services on Concourses T, E and F of the Airport; and

WHEREAS, based on a review by the Department of Aviation evaluation team, the Aviation General Manager and the Chief of Procurement Officer have recommended that Concessions Agreement FC-5215; Business and Entertainment at Hartsfield-Jackson Atlanta International Airport (“the Agreement”) be awarded to Business Traveler Services, Inc. (“BTS”).

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, that the Mayor is authorized to execute the Agreement with BTS.

BE IT FURTHER RESOLVED, that the Agreement will have an initial term of seven (7) years, with a single option to renew for an additional three (3) years, to be exercised at the City’s sole discretion.

BE IT FURTHER RESOLVED, that the City Attorney is directed to prepare the Agreement for execution by the Mayor.

BE IT FINALLY RESOLVED, that the Agreement will not become binding on the City and the City will incur no liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney and delivered to BTS.
