A SUBSTITUTE RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ENTER INTO AN AGREEMENT WITH LINEBARGER GOGGAN BLAIR & SAMPSON, LLC TO SERVE AS ONE OF THREE COLLECTIONS AGENCIES TO WHICH THE CITY OF ATLANTA MAY ALLOCATE FINANCIAL COLLECTION SERVICES FOR FC-5216, FOR DELINQUENT ACCOUNT RECEIVABLES AT A COMPENSATION RATE NOT TO EXCEED 20% OF PRINCIPAL AMOUNT COLLECTED FOR A TERM OF TWO YEARS WITH 2 ONE YEAR RENEWAL OPTIONS TO BE DEPOSITED TO AND PAID FROM FUND, DEPARTMENT ORGANIZATION AND ACCOUNT NUMBERS LISTED HEREIN; 7101 (AGENCY FUND) 100501 (DOF REVENUE AND COLLECTIONS) 5212001 (CONSULTING/ PROFESSIONAL SERVICES) 1515000 (TREASURY); 7101 (AGENCY FUND) 170503 (DWM WATERSHED BILLING & COLLECTION) 5212001 (CONSULTING AND PROFESSIONAL SERVICES) 4410000 (WATER ADMINISTRATION) ; 7101 (AGENCY FUND) 190191 (JDA MUNICIPAL COURT OPERATIONS) 5212001 (CONSULTING/PROFESSIONAL SERVICES) 2650000 (MUNICIPAL COURTS); AND 7101 (AGENCY FUND) 180108 (DOA AVIATION FINANCE & ACCOUNTING) 5212001 (CONSULTING AND PROFESSIONAL SERVICES) 7563000 (AIRPORT) AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta has an interest in providing a fair, efficient, and effective means for the recovery of monies owed to the City of Atlanta to ensure that the financial responsibilities of certain individuals do not become the burden of all of its citizens; and

WHEREAS, the City of Atlanta (the "City") did solicit from qualified consulting firms proposals for FC-5216, Financial Collection Services, on behalf of the Department of Finance, to assist the City in the collection of delinquent account receivables for the City; and

WHEREAS, in accordance with the guidelines contained in the Procurement Code, the Requests for Proposals ("RFP") for FC-5216 submitted by MSB Government Services,

Linebarger Goggan Blair & Sampson, LLP, and Penn Credit Corporation were deemed most responsible; and,

WHEREAS, this resolution does not obligate the City of Atlanta to allocate any specific account to any of the consulting firms awarded with the RFP for FC-5216, and is intended solely to permit the City to allocate accounts between the firms as it deems is in the best interest of the City of Atlanta; and

WHEREAS, the City, upon recommendations of the Chief Financial Officer and Chief Procurement Officer desires to enter into a two-year-agreement, with an option of two (2) one year options at the sole discretion of the City of Atlanta to commence upon the expiration of the initial term of agreement, provided such renewal is approved by Council; and

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor or his designee is hereby authorized to enter into an Agreement with Linebarger Goggan Blair & Sampson, LLP, to provide financial collection services for FC-5216 Financial Collection Services for delinquent account receivables on behalf of the Department of Finance.

BE IT FURTHER RESOLVED, that compensation shall be at a rate not to exceed 20% of the principal amount collected.

BE IT FURTHER RESOLVED, that the term of the agreement shall be two years with 2 one year renewal options at the sole discretion of the City of Atlanta to commence upon the expiration of the initial term of the agreement upon approval by the Council.

BE IT FURTHER RESOLVED, that the Chief Procurement Officer be and hereby is directed to prepare said Contract for execution by the Mayor, to be approved as to form by the City Attorney.

BE IT FURTHER RESOLVED, that all said services for said contract shall not become binding on the City of Atlanta, and the City of Atlanta shall not incur any liability nor obligation as to said Contract until the same has been signed by the Mayor and delivered to the contracting party.
