A RESOLUTION TO EXPRESS THE INTENT OF THE ATLANTA CITY COUNCIL TO COMPLETE THE 2011 REDISTRICTING PROCESS BY AMENDING ITS DISTRICT BOUNDARIES AS A RESULT OF THE 2010 DECENNIAL CENSUS AS REQUIRED BY ATLANTA CITY CHARTER SECTION 5-202, "REAPPORTIONMENT OF COUNCIL DISTRICTS."

WHEREAS, Charter amending ordinance 11-O-1670 has been introduced to amend the Council District boundaries as a result of the 2010 Decennial Census as required by Section 5-202 "Reapportionment of Council Districts" of the Charter of the City of Atlanta; and

WHEREAS, Alternative district maps identified as Plans 1, 2 and 3 have been proposed and considered by City Council and are attached herewith, along with related statistics and descriptions of changes from the current Council District map for each plan, all identified as Exhibit A; and

WHEREAS, these maps have been commented upon by members of the public through various methods including public hearings scheduled for that purpose; and

WHEREAS, it is necessary for the City Council to select one of these redistricting maps of new council district boundaries to attach to Charter Amendment Ordinance 11-O-1670 and to adopt as Council District boundaries pursuant to Section 5-202 of the City Charter; and

WHEREAS, the identification of a single map of new council district boundaries will allow for boundary descriptions of each of the twelve districts and the appropriate publisher's affidavit to be prepared for attachment to Charter amending Ordinance 11-O-1670.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that it is the intent of the Atlanta City Council that the map identified as Plan 2 be attached to Charter amending Ordinance 11-O-1670 and that the Council Districts represented thereon be adopted as a part of that ordinance in accordance with Section 5-202 of the Atlanta City Charter.
