

**A RESOLUTION TO ACCEPT THE DONATION OF TWO
FLASHCAM-880K CAMERAS FROM LIBERTY TIRE RECYCLING
COMPANY; AND FOR OTHER PURPOSES.**

WHEREAS, illegal tire dumping has been a problem in some parts of the City of Atlanta; and

WHEREAS, thousands of tires are dumped throughout the city on streets, behind buildings and inside abandoned houses and warehouses; and

WHEREAS, a Tire Commission has been created by the Atlanta City Council by Resolution 11-R-0770 to study, and identify steps and actions that the City of Atlanta can take to better manage the ever growing problem of discarded tires; and

WHEREAS, the Tire Commission has started the dialogue with meetings focusing on illegal tire dumping control and prevention; and

WHEREAS, the Commission has also received suggestions and recommendations from members and citizens; and

WHEREAS, one of the recommendations is to install surveillance cameras to deter the crime of illegal tires dumping; and

WHEREAS, Liberty Tire Recycling Company has donated two solar powered FlashCam-880K surveillance cameras, manufactured by Q-Star Technology, LLC, to the City of Atlanta.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the City of Atlanta hereby accepts two solar powered FlashCam-880K surveillance cameras, valued at \$5,995.00 each as shown in the attached invoice, from Liberty Tire Recycling Company.

SECTION 2: That all resolutions and parts of resolutions in conflict herewith are hereby repealed to the extent of the conflict.
