AN ORDINANCE AUTHORIZING THE CHIEF FINANCIAL OFFICER TO AMEND THE FY 2012 BUDGET BY TRANSFERRING APPROPRIATIONS IN THE TOTAL AMOUNT OF ONE HUNDRED AND EIGHTY THOUSAND (\$180,000.00) DOLLARS FROM NONDEPARTMENTAL BUDGET FOR PUBLIC ACCESS OPERATIONS AND SUPPORT; TO AUTHORIZE THE MAYOR TO ENTER INTO A NEW AGREEMENT WITH A PUBLIC ACCESS PROVIDER WHEN THE CURRENT AGREEMENT WITH PEOPLE TV, INC. TERMINATES; AND FOR OTHER PURPOSES

WHEREAS, this council approved execution of an Agreement with People TV, Inc. to operate its public access channel on September 8, 2009 in Resolution 09-R-1232;

WHEREAS, the City entered into an Agreement with People TV, Inc. (PEG Agreement) dated January 1, 2010 with a term to end on December 31, 2012;

WHEREAS, funding for People TV, Inc. was previously provided by a Comcast of Georgia! Virginia, Inc. per its Franchise Agreement with the City;

WHEREAS, state law no longer requires the franchisee to provide funding for People TV, Inc.;

WHEREAS, on September 8, 2009 this Council approved support to People TV, Inc. in the amount of \$500,000 to be distributed over the term of three years as follows; \$300,000 year one, \$100,000 year two and \$100,000 year three contingent upon the receipt of \$500,000 from Comcast of Virginia! Georgia, Inc. through Ordinance 09-01220;

WHEREAS, People TV, Inc. has provided notice that it will not be able to operate with its current budget;

WHEREAS, the current Franchise Agreement requires that should the City fail to produce 15 hours of original programming within 3 consecutive months, the City will lose the PEG channel;

WHEREAS, the City is committed to providing its constituents with a forum to broadcast public access content;

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:



SECTION 1: That the FY 2012 Budget is hereby amended as follows:

SECTION 2: That the City and Chief Financial Officer be authorized to redirect and rebudget the remaining \$100,000 that was contemplated to be the third and last payment under the PEG Agreement to the above appropriations.

SECTION 3: That as the current Agreement with People TV, Inc will be terminating, the Mayor is authorized to begin the process to enter into a new agreement for a new public access provider when said Agreement terminates.

SECTION 4: That in the event People TV, Inc. is unable to operate for the remaining term of its Agreement with the City, that the Mayor, with City Council approval, be authorized to enter into an Agreement for no longer than one year with a new entity to operate as our new public access provider using the appropriated funds herein.

SECTION 5: That the City Attorney is hereby directed to prepare appropriate contractual documents, to be approved by the City Attorney as to form; and that this agreement shall not become binding on the City and the City shall incur no liability upon same until the agreement has been executed by the Mayor, filed by the Municipal Clerk and delivered to the contracting parties.

SECTION 6: That all ordinances or parts of ordinances in conflict herewith are hereby waived to the extent of the conflict.
