A RESOLUTION BY

PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE

A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXERCISE A RENEWAL OPTION IN CONTRACT FC6006007952, WITH PROPERTYROOM.COM, FOR ONLINE AUCTION SERVICES, ON BEHALF OF THE DEPARTMENT OF POLICE, ALL REVENUES GENERATED UNDER THIS CONTRACT SHALL BE DEPOSITED INTO 1001 (GENERAL FUND) .240201 (APD POLICE ADMINISTRATION) .3511723 (VICTIM/WITNESS-BOND-FORFEIT) .3210000 (BUSINESS LICENSES).

WHEREAS, the City Council of Atlanta approved resolution 08-R-0068, authorizing the City of Atlanta ("City") to enter into agreement FC-6006007952 ("agreement") with Propertyroom.com, for online auction services, on behalf of the Department of Police ("Department"), pursuant to Section 2-1140 of Article X of the Procurement and Real Estate Code of the City of Atlanta Code of Ordinances; and

WHEREAS, the revenues generated under the contract are deposited into 1001 (General Fund).240201 (APD Police Administration).3511723 (Victim/Witness-Bond-Forfeit).3210000 (Business Licenses); and

WHEREAS, the term of the agreement with Propertyroom.com expires on 11 July 2011; and

WHEREAS, the agreement includes two (2) one (1) year renewal options, exercised at the sole discretion of the City of Atlanta; and

WHEREAS, the Chief of Police and the Chief Procurement Officer recommend exercising the renewal option with Propertyroom.com, as stipulated in the agreement, for online auction services, on behalf of the Department of Police.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor or his designee be and is hereby directed to exercise the first of two (2) one (1) year renewal options of agreement FC-6006007952, with Propertyroom.com, on behalf of the Department of Police, for online auction services.

BE IT FURTHER RESOLVED, that the Contract includes an additional one (1) year renewal option at the sole discretion of the City of Atlanta.

BE IT FURTHER RESOLVED, that the extension of this contractual agreement shall not become binding on the City, and the City shall incur no liability upon the same until the renewal option has been executed by the Mayor and delivered to the contracting party.

BE IT FINALLY RESOLVED, that all revenue generated from this contractual agreement shall be deposited into 1001 (General Fund).240201 (APD Police Administration).3511723 (Victim/Witness-Bond-Forfeit).3210000 (Business Licenses).
