**WHEREAS**, the City of Atlanta ("City") entered into Contract Number FC-6006007938C, Citywide Demolition Services ("Contract") with Mack's Hauling, Inc., ("Mack"), pursuant to Resolution Number 07-R-2541 adopted by the Atlanta City Council on December 3, 2007 and approved by the Mayor on December 11, 2007; and

**WHEREAS**, the Contract had a term of three (3) years with two (2) one year renewal options and will expire on December 23, 2011; and

**WHEREAS**, the City exercised its renewal option and authorized entering into Renewal Agreement No. 1 and Amendment 5 to the Agreement with Mack adding the City's Department of Watershed Management as an authorized user under the Agreement pursuant to Resolution Number 11-R-1594 adopted by the Atlanta City Council on November 7, 2011 and approved by the Mayor on November 15, 2011; and

**WHEREAS**, the Department of Planning and Community Development ("DPCD") continues to require City-wide demolition services and desires to increase the not to exceed amount of the Agreement by an additional One Hundred Thousand Dollars (\$100,000.00) while it completes the procurement process for a new demolition services agreement; and

**WHEREAS**, Mack has performed satisfactorily under the Contract; and

**WHEREAS**, the Commissioner of DPCD and the Chief Procurement Officer recommend increasing the Agreement amount with Mack by an additional One Hundred Thousand Dollars (\$100,000.00).



**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES**, that the Mayor, on behalf of the City, is hereby authorized to enter into Amendment No. 6 to the Agreement (“Amendment 6”) to Contract Number FC-6006007938C, Citywide Demolition Services, with Mack increasing the Agreement amount by an additional One Hundred Thousand Dollars (\$100,000.00).

**BE IT FURTHER RESOLVED**, that all contracted work shall be charged to and paid from 1001 (General Fund) 250301 (Director of Code Compliance) 5212001 (Consulting and Professional Service) 7210000 (Protective Inspection Admin.); 25210796 (DEMO 2011) 3940 (HSNG DEMO 2011 OCC) 220131962 (CDBG 2011); 25210796 (DEMO 2010) 3690 (HSNG DEMO 2010 OCC) 220131898 (CDBG 2010); 25210419 (DEMO 2009) 3241( HSNG DEMOITION 2009) 220130083 (CDBG 1999); 25210419 (DEMO 2009) 3241 (HSNG DEMOITION 2009) 220130063 (CDBG 1996); 25210419 (DEMO 2009) 3241 (HSNG DEMOITION 2009) 220130050 (CDBG 2007).

**BE IT FURTHER RESOLVED**, that the City Attorney is hereby directed to prepare Amendment 6 for execution by the Mayor.

**BE IT FINALLY RESOLVED**, that Amendment 6 will not become binding upon the City, and the City will incur no obligation or liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved by the City Attorney as to form and delivered to Mack.
