

**A RESOLUTION AUTHORIZING THE MAYOR TO AWARD AND EXECUTE AN AGREEMENT WITH AIRPORT LOUNGE DEVELOPMENT, INC. FOR FC-5180 COMMON USE LOUNGES- CONCOURSES E AND F AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta ("City"), owns and operates Hartsfield-Jackson Atlanta International Airport ("the Airport") and

**WHEREAS**, the City solicited proposals, on behalf of the Department of Aviation, for qualified concessionaires to provide common use lounge concessions services on Concourses E and F; and

**WHEREAS**, one (1) responsive proposal was submitted in response to the solicitation; and

**WHEREAS**, the proposal was reviewed and evaluated, and the Aviation General Manager and the Chief of Procurement Officer have recommended that the agreement for FC-5180, Common Use Lounges-Concourses E and F be awarded to Airport Lounge Development, Inc. ; and

**WHEREAS**, said agreement will have an initial term of seven (7) years, with one (1) three (3) year renewal option at the City's sole option.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA**, that the Mayor is authorized to award and execute an agreement with Airport Lounge Development Inc. for FC- 5180, Common Use Lounges-Concourses E and F.

**BE IT FURTHER RESOLVED**, that said agreement will have an initial term of seven (7) years, with one (1) three (3) year renewal option at the City's sole option.

**BE IT FURTHER RESOLVED**, that the City Attorney is directed to prepare the Agreement for execution by the Mayor, with the same to be approved as to form by the City Attorney.

**BE IT FINALLY RESOLVED**, that said agreement will not become binding on the City and the City will incur no liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney, and delivered to Airport Lounge Development, Inc.






