




WHEREAS, the City of Atlanta ("City") entered into an agreement for FC-4906A, Annual Contract for Architectural and Engineering Services with Arcadis/Brindley Pieters & Associates, Joint Venture; and

WHEREAS, the term of the agreement is for a period of two (2) years with an option to renew for three (3) one (1) year additional periods; and

WHEREAS, the Contractor has performed contracted services satisfactorily; and

WHEREAS, the Commissioners of the Departments of Public Works and Watershed Management have recommended Renewal Agreement No. 1 for FC-4906A, Annual Contract for Architectural and Engineering Services, to be executed with Arcadis/Brindley Pieters & Associates, Joint Venture.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES**, that the Mayor is hereby authorized to enter into Renewal Agreement No. 1 with Arcadis/Brindley Pieters & Associates, Joint Venture for FC-4906A, Annual contract for Architectural and Engineering Services on behalf of the Departments of Public Works and Watershed Management.

**BE IT FURTHER RESOLVED**, that term of the Agreement shall be December 21, 2011 through December 20, 2012.

**BE IT FURTHER RESOLVED**, that the Chief Procurement Officer is hereby directed to prepare an appropriate Renewal Agreement No. 1 for execution by the Mayor to be approved by the City Attorney as to form.

**BE IT FURTHER RESOLVED**, that the Renewal Agreement No. 1 shall not become binding on the City, and the City shall incur no liability upon the same until such contract has been executed by the Mayor and delivered to Arcadis/Brindley Pieters & Associates, Joint Venture.

**BE IT FURTHER RESOLVED**, that said Agreement shall not become binding on the City until a resolution of notice to proceed is adopted which identifies the specific funding sources and amount.



**BE IT FINALLY RESOLVED**, that all services for said contracted work shall be charged to and paid from various Fund Department and Account numbers and funding sources.
