Municipal Clerk Rhonda Dauphin Johnson sounded the caption to Communication 12-C-0608. Following, Councilmember Smith was recognized and made a Motion to File. It was Seconded by Councilmember Martin and the Motion CARRIED by a roll call vote of 10 yeas; 0 nays.

Following the vote of Communication 12-C-0608, Councilmember Martin made a Motion to Enter Executive Session to discuss personnel matters regarding the Council Director's role. The Motion was Seconded by Councilmember Smith and CARRIED by a roll call vote of 10 yeas (Councilmembers Smith, Winslow, Archibong, Wan, Adrean, Moore, Martin, Bottoms, Sheperd, and Bond); 0 nays; thus Council retreated into Executive Session.

Council re-entered Regular Session.

It was Seconded by Councilmember Smith and the Motion CARRIED by a roll call vote of 10 yeas; (Councilmembers Smith, Winslow, Archibong, Wan, Adrean, Moore, Martin, Sheperd, Bond and Watson); 0 nays.
