**AN ORDINANCE
BY COUNCILMEMBER MICHAEL JULIAN BOND AND KEISHA LANCE BOTTOMS,**

AUTHORIZING THE MAYOR OR HIS DESIGNEE TO INSTALL A TRAFFIC SIGNAL AT THE INTERSECTION OF COUNTY LINE ROAD, SW AND TELL AND BUTNER ROADS, SW; AND FOR OTHER PURPOSES.

WHEREAS, residents and drivers in the neighborhoods surrounding the intersection of County Line Road, SW and Tell and Butner Roads, SW have expressed their concerns regarding the high volume and speed of traffic that passes through this intersection; and

WHEREAS, the intersection has poor visibility and a sharp curve that causes driver confusion; and,

WHEREAS, the Butner Learning Center, which serves infants, toddlers and pre-school age children, is located at the heart of the intersection; and

WHEREAS, the need to mitigate the hazard and risk faced by pedestrians and motorists.

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the Mayor or his designee is authorized to install a traffic signal at the intersection of County Line Road, SW and Tell and Butner Roads, SW.

Section 2: That all ordinances and parts of ordinances in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of the conflict.
