AN ORDINANCE AMENDING THE FY 2011 (COMMUNITY DEVELOPMENT FUND) BUDGET BY ANTICIPATING AND APPROPRIATING IN THE AMOUNT OF FIFTY ONE THOUSAND SEVEN HUNDRED FIVE DOLLARS AND FOURTEEN CENTS (\$51,705.14) FOR THE PURPOSE OF REPROGRAMMING FUNDS UNDER THE HOMELESSNESS PREVENTION AND RAPID RE-HOUSING PROGRAM (HPRP) OF THE AMERICAN RECOVERY AND REINVESTMENT ACT (ARRA) OF 2009; AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT AMENDMENT WITH TRAVELERS AID OF METROPOLITAN ATLANTA, INC. FOR PROJECT HPR-08-12, HOPE ATLANTA HOMELESS PREVENTION AND RAPID RE-HOUSING; AND FOR OTHER PURPOSES.

WHEREAS, on July 20, 2009, pursuant to Resolution 09-R-0680, the City of Atlanta (the "City") received a grant from the U. S. Department of Housing and Urban Development (HUD) in the amount of Three Million, Four Hundred Forty One Thousand, Ninety One Dollars and No Cents (\$3,441,091.00) to implement the Homelessness Prevention and Rapid Re-Housing Program (the "HPRP"), a program under the American Recovery and Reinvestment Act (the "ARRA"); and

WHEREAS, two projects with funds remaining, St. Jude's Homeless Prevention and Achor Center, have been terminated at the agencies' request; and

WHEREAS, these projects have a total balance of Fifty One Thousand Seven Hundred Five Dollars and Fourteen Cents (\$51,705.14) remaining; and

WHEREAS, it is in the best interest of the City to reprogram these funds to the HOPE Atlanta Homeless Prevention and Rapid Re-Housing project, which is spending timely and serving the broadest range of HPRP-eligible needs; and

WHEREAS, after reprogramming, the amended total for the HOPE Atlanta Homeless Prevention and Rapid Re-Housing projects would be Five Hundred Fifty Seven Thousand Eight Hundred Twenty Five Dollars and Fourteen Cents (\$557,825.14); and

WHEREAS, this project has obtained the necessary environmental clearance from the U.S. Department of Housing and Urban Development and is ready for implementation;

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

Section 1: That the FY 2011 (Community Development Fund) Budget be and is amended as shown on Attachment 1.

Section 2: That the Mayor or his designee be and is hereby authorized to enter into a contract amendment as follows:

Section 4: That said contractual amendment shall not become binding on the City and the City shall incur no liability upon the same until such contract is approved by the City Attorney as to form, executed by the Mayor or his designee, attested to by the Municipal Clerk, and delivered to the contracting party.
