AMENDING THE 2012 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF \$17,290.00 FOR THE PURPOSE OF PREPARING THE "MCPHERSON & WALKER MONUMENTS CONDITIONS ASSESSMENT PROJECT"; AND FOR OTHER PURPOSES.

WHEREAS, the Georgia Department of Natural Resources seeks applications from Certified Local Governments for federal Historic Preservation Fund Grants to fund the preparation of historic resource surveys, National Register of Historic Places nominations, preservation planning projects, information and educational activities, and other historic preservation-related projects; and

WHEREAS, the Urban Design Commission, as a Certified Local Government and as part of the Department of Planning and Community Development, qualifies for such funding;

WHEREAS, as a matter of public policy the Urban Design Commission is charged with safeguarding the City's historic, aesthetic, and cultural heritage; fostering civic pride in accomplishments of the past; enhancing the City's attractions to tourists; and raising the level of community understanding and expectation for quality in the built environment; and

WHEREAS, Resolution 11-R-0241 authorized the Commissioner of the Department of Planning and Community Development or his designee, on behalf of the Mayor, to apply for, accept and sign all necessary grant agreements with the Georgia Department of Natural Resources for funding in an amount not to exceed Twenty Five Thousand Dollars (\$25,000.00) for a 2011 Historic Preservation Fund CLG Predevelopment grant; and

WHEREAS, the Director of the Urban Design Commission as the representative of the Commissioner and the City of Atlanta has duly applied for and the City of Atlanta has been awarded a matching Federal matching grant in the amount of Seventeen Thousand Two Hundred Ninety Dollars (\$17,290.00) for the preparation of the "McPherson & Walker Monuments Conditions Assessment Project"; and

WHEREAS, the grant documentation specifies that the local matching share of the grant (40% of the total project cost) shall be provided by The Battle of Atlanta Commemoration Organization, Inc. ("BATL") through their own funding, fundraising, in-kind services, and donations;

NOW THEREFORE THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS, as follows:



Section 1: That the 2012 (Intergovernmental Grant Fund) Budget, Department of Planning, and Community Development, be and is hereby amended as follows:
