PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

AN ORDINANCE TO AMEND THE 2011 INTERGOVERNMENTAL/GRANT FUND BUDGET OFFICE OF THE MAYOR, BY ADDING TO ANTICIPATIONS, AND APPROPRIATIONS IN THE AMOUNT OF THIRTY NINE THOUSAND DOLLARS FOUR HUNDRED AND NINETY FOUR DOLLARS AND NO CENTS (\$39,494.00) FROM THE STATE OF GEORGIA GOVERNOR'S OFFICE OF CHILDREN AND YOUTH AND TWENTY FIVE THOUSAND FOUR HUNDRED AND FORTY EIGHT DOLLARS AND NO CENTS (\$25,448.00) FROM THE CITY OF ATLANTA MATCHING FUNDS FOR THE INTENSIVE SURVEILLANCE OFFICERS PROGRAM AND FOR OTHER PURPOSES.

WHEREAS, the State of Georgia through the Juvenile Accountability Block grant strengthens the juvenile justice system by increasing the capacity to develop youth competence, to efficiently track juveniles through the system, and to provide enhanced options such as restitution, community service, victim-offender mediation, and other restorative justice sanctions that reinforce the mutual obligations of an accountability-based juvenile justice system; and

WHEREAS, the City of Atlanta has been notified of the availability of funding to support the Intensive Surveillance Officer program; and

WHEREAS, the City of Atlanta wishes to accept funding to support the Intensive Surveillance Officer Program; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: The Mayor is hereby authorized to accept and appropriate grant award from the State of Georgia in the amount of Thirty Nine Thousand Four Hundred and Four Dollars and No cents (\$39,494.00). That the 2011 Intergovernmental/Grant Fund Budget be and is amended as follows:
