**A RESOLUTION AUTHORIZING THE MAYOR TO AWARD AND EXECUTE AN AGREEMENT WITH LENLYN LIMITED d/b/a INTERNATIONAL CURRENCY EXCHANGE FOR FC-5236 FOREIGN CURRENCY EXCHANGE SERVICES - CONCOURSES E AND F AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta ("City") owns and operates Hartsfield-Jackson Atlanta International Airport ("Airport"); and

**WHEREAS**, the Department of Procurement solicited proposals for FC-5236, Foreign Currency Exchange Services - Concourses E and F, on behalf of the Department of Aviation; and

**WHEREAS**, qualified firms submitted proposals for the opportunity to construct, operate, maintain, and manage the domestic and international terminals currency exchange activities at the Airport; and

**WHEREAS**, the proposals were received and evaluated, and the Aviation General Manager and the Chief Procurement Officer have recommended that the agreement for FC-5236, Foreign Currency Exchange Services - Concourses E and F be awarded to the Lenlyn Limited d/b/a International Currency Exchange; and

**WHEREAS**, said agreement has an initial term of seven (7) years, with one (1) three (3) year renewal option at the City's sole option.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the Mayor is authorized to award and execute an agreement with Lenlyn Limited d/b/a International Currency Exchange for FC-5236, Foreign Currency Exchange Services - Concourses E and F.

**BE IT FURTHER RESOLVED**, that said agreement has an initial term of seven (7) years, with one (1) three (3) year renewal at the City's sole option.

**BE IT FURTHER RESOLVED**, that the City Attorney is directed to prepare an agreement for execution by the Mayor, with same to be approved as to form by the City Attorney.

**BE IT FINALLY RESOLVED**, that said agreement shall not become binding on the City, and the City shall incur no liability hereunder until such agreement has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney, and delivered to Lenlyn Limited d/b/a International Currency Exchange.
