A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN AMENDMENT TO AND RENEWAL OF CONCESSIONS AGREEMENT FC-6006007895, FULL SERVICE COMMERCIAL BANK AND FOREIGN CURRENCY EXCHANGE SERVICES WITH WELLS FARGO BANK, N.A.; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City"), as owner and operator of Hartsfield-Jackson Atlanta International Airport ("Airport") has entered into FC-6006007895, Full Service Commercial Bank and Foreign Currency Exchange Services ("Agreement") with Wells Fargo Bank, N.A. ("Wells Fargo") dated May 23, 2007; and

WHEREAS, the initial term of the Agreement expires April 15, 2012 and includes an option to renew the Agreement for an additional five-year period to be exercised at the City's sole discretion; and

WHEREAS, Wells Fargo has provided the services required by the Agreement satisfactorily; and

WHEREAS, the City also desires to relocate the Premises to enable the expansion of the City's food & beverage concessions program within the Airport Atrium; and

WHEREAS, appropriate space for the banking services concessions is available in the west crossover area at the Airport; and

WHEREAS, the Aviation General Manager and the Chief Procurement Officer have recommended that the City amend the Agreement to enable the relocation of the banking services concession and renew the Agreement for an additional five years.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF ATLANTA, GEORGIA, that the Mayor is authorized to execute on behalf of the City an Amendment to and Renewal of the Agreement ("Amendment and Renewal") with Wells Fargo to enable the relocation of the banking services concession to the west crossover area at the Airport and to renew the Agreement for an additional five years.

BE IT FURTHER RESOLVED, that the City Attorney is directed to prepare the Amendment and Renewal for execution by the Mayor.

BE IT FINALLY RESOLVED, that the Amendment and Renewal will not become binding on the City and the City will incur no liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved by the City Attorney as to form and delivered to Wells Fargo.
