A RESOLUTION AUTHORIZING THE MAYOR TO AMEND THE REQUESTED GRANT APPLICATION AMOUNT, AUTHORIZED IN RESOLUTION 11-R-1406, IN ORDER TO APPLY FOR A LIVABLE CENTERS INITIATIVE (LCI) GRANT FROM THE ATLANTA REGIONAL COMMISSION (ARC) IN AN AMOUNT NOT TO EXCEED ONE HUNDRED AND EIGHTY-SEVEN THOUSAND FIVE HUNDRED DOLLARS AND NO CENTS (\$187,500) IN ORDER TO CONDUCT AN LCI STUDY FOR THE MEMORIAL DRIVE LCI; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta participates in the Livable Communities Initiative (LCI) program sponsored by the Atlanta Regional Commission (ARC); and

WHEREAS, the purpose of the LCI program is to define activity centers and corridors in local jurisdictions to help spur private and public investment in and adjacent to these centers; and

WHEREAS, the City has received notification from the ARC that funds are available for new LCI corridor studies; and

WHEREAS, Resolution 11-R-1406 adopted by the City Council on October 17, 2011 authorized the Mayor to apply for LCI funding in the amount of One Hundred Fifty Thousand Dollars (\$120,000) for the Memorial Drive corridor; and

WHEREAS, the City desires to authorize the Mayor to apply for an LCI a grant from the ARC, in an amount not to exceed One Hundred and Eighty-Seven Thousand Five Hundred Dollars (\$187,500) in order to conduct a LCI study for the Memorial Drive corridor; and

WHEREAS, in the event that the City receives said grant, the ARC requires 20 % matching funds for the grant amount approved by the ARC; and

WHEREAS, matching funds for this study will be provided from the District 5 Councilmember Accounts.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

BE IT FURTHER RESOLVED: That the Mayor is hereby authorized to amend any previously applied for Livable Centers Initiative (LCI) grant from the Atlanta Regional



Commission (ARC) for the Memorial Drive LCI in an amount not to exceed \$187,500;
and

BE IT FINALLY RESOLVED, that the Memorial Drive LCI will require 20% in matching funds to be provided by the City of Atlanta, District 5 Councilmember Accounts.
