AN ORDINANCE AMENDING THE FY 2011 (INTERGOVERNMENTAL GRANT FUND) BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF SIXTY THOUSAND DOLLARS AND NO CENTS (\$60,000.00) FOR THE PURPOSE OF REPROGRAMMING HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS (“HOPWA”) FUNDS; AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT AMENDMENT WITH AID GWINNETT, INC. FOR PROJECT HP-10-04, AID GWINNETT; AND FOR OTHER PURPOSES

WHEREAS, AID Gwinnett was approved for funding under the City of Atlanta’s (“City”) 2010 Annual Action Plan of the 2010 – 2014 Consolidated Plan submitted to the U.S. Housing and Urban Redevelopment (“HUD”); and

WHEREAS, AID Gwinnett was funded for Five Hundred Fifty Thousand One Hundred Thirty Five Dollars and No Cents (\$550,135.00) in 2010 to provide tenant-based rental assistance for persons with HIV/AIDS; and

WHEREAS, AID Gwinnett has requested an additional Sixty Thousand Dollars and No Cents (\$60,000.00) to provide rental assistance for twelve (12) persons; and

WHEREAS, the Cobb County Board of Health Housing Opportunities for Persons With AIDS (“HOPWA”) project is completed and has funds remaining; and

WHEREAS, the City desires to support AID Gwinnett’s efforts to provide rent assistance to persons with HIV/AIDS by reprogramming Sixty Thousand Dollars and No Cents (\$60,000.00) from the Cobb County Board of Health HOPWA project; and

WHEREAS, after reprogramming, the amended total for the AID Gwinnett project would be Six Hundred Ten Thousand One Hundred Thirty Five Dollars and No Cents (\$610,135.00); and

WHEREAS, this project has obtained the necessary environmental clearance from the U.S. Department of Housing and Urban Development and is ready for implementation;

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS, as follows:

Section 1: That the 2011 (Intergovernmental Grant Fund) Budget be and is amended as shown on the Attachment 1.

Section 2: That the Mayor or his designee be and is authorized hereby to enter into a contract amendment as follows:

Section 3: That the City Attorney be and is hereby directed to prepare the appropriate contractual amendment for execution by the Mayor or his designee.

Section 4: That said contractual amendment shall not become binding on the City and the City shall incur no liability upon same until such contract is approved by the City Attorney as to form, executed by the Mayor or his designee, attested to by the Municipal Clerk, and delivered to the contracting party.

Section 5: That all ordinances and parts of ordinances in conflict with this ordinance are hereby waived to the extent of the conflict.
