AN ORDINANCE AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO PROHIBIT PARKING FROM 8:00 a.m. TO 9:00 a.m. and 3:15 p.m. to 4:15 p.m. ON SCHOOL DAYS ALONG THE NORTH CURB LANE OF VIRGINIA AVENUE, N.E. FROM GREENCOVE AVE. TO THE DRIVEWAY OF INMAN MIDDLE SCHOOL; TO INSTALL SIGNS INDICATING RIGHT HAND TURN ONLY 8:00 a.m. to 9:00 a.m. and 3:15 p.m. to 4:15 p.m. MONDAY TO FRIDAY WHEN ENTERING AND LEAVING INMAN MIDDLE SCHOOL DRIVEWAY ON VIRGINIA AVE. NE; AND FOR OTHER PURPOSES.

WHEREAS, Samuel M. Inman Middle School, located at 774 Virginia Avenue NE is a thriving school in the Atlanta Public Schools System; and

WHEREAS, Inman Middle School is attended by approximately 870 students each day, who ride one of the 11 buses, walk to school or carpool; and

WHEREAS, the current walking and carpool traffic patterns create unsafe and hazardous conditions for the students and their families, especially those attempting to cross Virginia Avenue at the crosswalk as they enter and leave Inman; and

WHEREAS, the current carpool traffic patterns create traffic backups blocking the eastbound lane of Virginia Avenue as cars wait to turn left to enter the Inman School driveway; and

WHEREAS, the Inman Principal, Atlanta Public School Safety administration and parents invited Department of Public Works/Office of Transportation to the school to review the traffic patterns and recommend safety measures that could increase the safety of the students and families, and provide safe passage to passing vehicular traffic; and

WHEREAS, the Department of Public Works/Office of Transportation visited the school, met with administration and parents, studied the traffic patterns at dismissal and arrival, and evaluated safety measures; and

WHEREAS, the Department of Public Works Office of Transportation witnessed the unsafe conditions at Inman Middle School during student arrival and dismissal times; and

WHEREAS, the Department of Public Works Office of Transportation has determined appropriate safety measures and agreed to implement the measures.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Mayor, or his designee, is authorized to install signs along the northern curb lane of Virginia Ave. NE from Greencove Ave. NE to the driveway of Inman Middle School, at 774 Virginia Ave. NE, indicating parking restriction 8:00 a.m. to 9:00 a.m. and 3:15 p.m. to 4:15 p.m. on school days.



SECTION 2: That the Mayor, or his designee, is authorized to install signs indicating that traffic movement is limited to right-in and right-out only 8:00 a.m. to 9:00 a.m. and 3:15 p.m. to 4:15 p.m. Monday to Friday when entering and exiting Inman Middle School driveway on Virginia Avenue.

SECTION 3: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed in this instance only.
