**A RESOLUTION AUTHORIZING THE MAYOR, OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO PARTICIPATE WITH THE PIEDMONT PARK CONSERVANCY IN THE NORTH WOODS EXPANSION OF PIEDMONT PARK BY PROVIDING AN AMOUNT NOT TO EXCEED TWO HUNDRED THOUSAND DOLLARS AND NO CENTS (\$200,000.00) TOWARDS COMPLETION OF A CARRIAGE ROAD IN THE NORTH WOODS PORTION OF PIEDMONT PARK, WITH ALL FUNDS BEING CHARGED TO AND PAID FROM FUND, DEPARTMENT, ORGANIZATION AND ACCOUNT NUMBERS: 7701 (TRUST FUND) 140106 (PRC PARKS DESIGN) 5212001 (CONSULTING/PROFESSIONAL) 6220000 (PARK AREAS) 600023 (PIEDMONT PARK RESTAURANT) 69999 (FUNDING SOURCE FOR NON CA)- \$35,000.00 & 7701 (TRUST FUND) 140106 (PRC PARKS DESIGN) 5212001 (CONSULTING/PROFESSIONAL) 6220000 (PARK AREAS) 600356 (GREENSPACE PROGRAM) 69999 (FUNDING SOURCE FOR NON CA)- \$165,000.00; AND FOR OTHER PURPOSES.**

**WHEREAS**, the Piedmont Park Conservancy (“PPC”) is a 501(c)(3) non-profit organization dedicated to the preservation and restoration of Piedmont Park located in Atlanta, Georgia, (the “Park”), to the benefit of both the citizens of Atlanta and its many visitors; and

**WHEREAS**, PPC has initiated the North Woods expansion, which would transform over 53 acres of unusable and inaccessible land into active and passive recreational space within the Park. The North Woods expansion contains old growth forest, a wetland area, adds new entrances into the Park, and provides access to the public to thousands of historic and newly planted native trees; and

**WHEREAS**, PPC has raised over Thirty Eight Million Dollars (\$38,000,000.00) and received a matching One Million Dollar (\$1,000,000.00) grant from The Kendeda Fund towards the North Woods expansion; and

**WHEREAS**, PPC wishes to complete construction of a carriage road in the North Woods portion of the Park, which will add paved roads and curbing in this expanded area of the Park (the “Project”); and

**WHEREAS**, the Department of Parks, Recreation and Cultural Affairs desires to participate in the Project by providing funds to PPC in an amount not to exceed Two Hundred Thousand Dollars and No Cents (\$200,000.00) that will allow for completion of the Project; and

**WHEREAS**, the City is appreciative of the contributions of the PPC and finds that it is in the City’s best interest to assist the PPC in completing this Project.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES**, that the Mayor or his designee, on behalf of the City, is hereby authorized to provide funds in an amount not to exceed Two Hundred Thousand Dollars and NO Cents



(\$200,000.00) to the Piedmont Park Conservancy to be used toward the construction of the Project at the Park.

**BE IT FURTHER RESOLVED**, that the City hereby accepts the contributions of the Piedmont Park Conservancy.

**BE IT FINALLY RESOLVED**, that all funds shall be charged to and paid from the following Fund, Department, Organization and Account Numbers: 7701 (Trust Fund) 140106 (PRC Parks Design) 5212001 (Consulting/Professional) 6220000 (Park Areas) 600023 (Piedmont Park Restaurant) 69999 (Funding Source for Non CA)- \$35,000.00 & 7701 (Trust Fund) 140106 (PRC Parks Design) 5212001 (Consulting/Professional) 6220000 (Park Areas) 600356 (Greenspace Program) 69999 (Funding Source for Non CA)- \$165,000.00.
