AN ORDINANCE AMENDING THE 2012 ATLANTA WORKFORCE DEVELOPMENT AGENCY AHA CATALYST PROGRAM GRANT BUDGET AS PASSED IN RESOLUTION 10-R-1577, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS THE AMOUNT OF TWO HUNDRED TWELVE THOUSAND DOLLARS (\$212,000) REFLECTING AN INCREASED GRANT ADJUSTMENT FROM THE HOUSING AUTHORITY OF THE CITY OF ATLANTA (“AHA”) FOR THE PURPOSE OF SUPPORTING AHA-ASSISTED FAMILIES IN MEETING AHA CATALYST WORK REQUIREMENTS; FOR A TOTAL GRANT BUDGET OF \$1,462,000; AND FOR OTHER PURPOSES.

WHEREAS, the purpose of the Atlanta Workforce Development Agency (“AWDA”) is to serve the citizens of the City of Atlanta (“the City”) by providing employment, job training, career development, job readiness, job placement and other supportive services; and

WHEREAS, the AHA requires all non-disabled adults between the ages of 18 and 61 receiving housing assistance from AHA to be engaged in at least thirty (30) hours a week of employment, education and/or job training pursuant to the CATALYST Work Requirement (“CATALYST Requirement”); and

WHEREAS, the City is willing to support AHA-assisted families who are not currently in compliance with the CATALYST Requirement; and

WHEREAS, the City authorized a previous resolution to accept up to \$1,250,000 in grants under the Catalyst program in 10-R-1577; and

WHEREAS, the City has been notified that the amount of grant support will be increase up to \$1,462,000 over a five year period; and

WHEREAS, the City desires to enter into a new intergovernmental agreement (“Agreement”) with AHA to accept this increased amount of grant support; and

WHEREAS, AWDA now recommends increasing receipts in the 2012 Budget by Two Hundred Twelve Thousand Dollars (\$212,000) over five years.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the 2012 AHA Catalyst Budget be increased by Two Hundred Twelve Thousand Dollars (\$212,000) over five years for a total of \$1,462,000 per the adjustment found in Exhibit A attached hereto.

Section 2: That the Mayor is authorized to execute documents necessary to facilitate any increases in grant dollars for the Catalyst grant.

Section 3: That the 2012 AHA Catalyst Budget is hereby amended as follows:
