**A RESOLUTION BY

**A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH ALLIED AVIATION FUELING OF ATLANTA, INC. FOR PROJECT NUMBER FC-5303, FUEL STORAGE FACILITY AND FUELING FACILITY OPERATION AND MANAGEMENT, AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT IN AN AMOUNT NOT TO EXCEED \$407,823.00 FOR THE REMAINDER OF FISCAL YEAR 2012. ALL SERVICES WILL BE CHARGED TO AND PAID FROM FDOA: 5501 (AIRPORT REVENUE FUND) 180302 (DOA AVIATION MAINTENANCE AIRFIELD) 5212001 (CONSULTING PROFESSIONAL SERVICES) 7563000 (AIRPORT); AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta (the "City") solicited bids for Project Number FC-5303, Fuel Storage Facility and Fueling Facility Operation and Management, on behalf of the Department of Aviation; and

**WHEREAS**, the Aviation General Manager and the Chief Procurement Officer have recommended that the Contract for FC-5303, Fuel Storage Facility and Fueling Facility Operation and Management be awarded to the top ranked, responsive, and responsible Proponent, Allied Aviation Fueling of Atlanta, Inc.

**WHEREAS**, the term of the agreement is for five years with one-year renewal option.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the Mayor is authorized to execute a Contractual Agreement with Allied Aviation Fueling of Atlanta, Inc. on behalf of the Department of Aviation, in an amount not to exceed \$407,823.00 for the remainder of Fiscal Year 2012.

**BE IT FURTHER RESOLVED**, that the City Attorney is hereby directed to prepare a Contractual Agreement for execution by the Mayor, to be approved by the City Attorney as to form.

**BE IT FURTHER RESOLVED**, that the term of the agreement is for five years with a one-year renewal option.

**BE IT FURTHER RESOLVED**, that all contracted work will be charged to and paid for from FDOA: 5501 (Airport Revenue Fund) 180302 (DOA Aviation Maintenance Airfield) 5212001 (Consulting Professional Services) 7563000 (Airport).

**BE IT FURTHER RERSOLVED**, that funding for Fiscal Year 2013 and beyond will be established annually in accordance with the terms of the Contract, and will be contained in the Department of Aviation's annual operating budget; all of such compensation is recoverable from the Fuel Facility users.



**BE IT FINALLY RESOLVED**, that the Agreement shall not become binding upon the City and the City will incur no obligation or liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved by the City Attorney as to form and delivered to Allied Aviation Fueling of Atlanta, Inc.
