**AN ORDINANCE**

**BY COUNCILMEMBER CLETA WINSLOW**

**AN ORDINANCE TO RENEW AND RE-DESIGNATE THE DRUG FREE COMMERCIAL ZONE LOCATED IN THE PITTSBURGH COMMUNITY AND DESIGNATED AS "ZONE III, MCDANIEL"; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta has an interest in the public health, safety and welfare of its citizens and visitors; and

**WHEREAS**, due to a significantly high incidence of conduct associated with drug trafficking, the City, pursuant to state law, designated certain areas of the city as Drug Free Commercial Zones; and

**WHEREAS**, in March, 1998, the City, pursuant to Ordinance 98-O-0328, designated several Drug Free Commercial Zones; and

**WHEREAS**, pursuant to O.C.G.A. § 16-13-32.6 (d) "A drug-free commercial zone adopted by the General Assembly shall remain in effect for five years and shall expire five years from the effective date of such adoption by the General Assembly."; and

**WHEREAS**, the Drug Free Commercial Zones created by the City in 1998, were adopted by the General Assembly in March, 1999; and

**WHEREAS**, the City's Drug Free Commercial Zones were re-designated in January, 2004 pursuant to Ordinance 03-O-2221 and were subsequently adopted by the General Assembly in May, 2004; and

**WHEREAS**, if, pursuant to the state law provision cited above, Drug Free Commercial Zones must be renewed or re-designated every five years, Drug Free Commercial Zones in the City of Atlanta should have been renewed or re-designated on or before May, 2009; and

**WHEREAS**, the City has not renewed or re-designated its Drug Free Commercial Zones since January, 2004; and



**WHEREAS**, the drug trafficking situation is so dire and pervasive in one of the City's existing Drug Free Commercial Zones located in the Pittsburgh Community, that immediate legislative attention and action is warranted.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, as follows:**

**Section 1:** The Drug Free Commercial Zone described in Section 106-403 (a) of the Code of Ordinances of the City of Atlanta as:

***Zone III, McDaniel: An area contained within a northern boundary of I-20; a southern boundary of University Avenue; a western boundary of Northside Drive; and an eastern boundary of I-75.***

Is hereby renewed and re-designated as a Drug Free Commercial Zone retroactive to May 17, 2009 and shall be amended to add the word "Police" before the word "Zone", such that said Drug Free Commercial Zone shall be titled and identified as:

***Police Zone III, McDaniel: An area contained within a northern boundary of I-20; a southern boundary of University Avenue; a western boundary of Northside Drive; and an eastern boundary of I-75.***

**Section 2:** The Commissioner of the Department of Public Works is hereby authorized to take every necessary action to ensure the posting of the required signage in prominent and conspicuous places on the boundaries and throughout any portion of the Drug Free Commercial Zone described in this ordinance.

**Section 3:** All ordinances or parts of ordinances in conflict herewith are hereby waived to the extent of any such conflict.
