**A RESOLUTION TO REQUEST AND AUTHORIZE THE CITY AUDITOR THROUGH THE AUDIT COMMITTEE TO ASSIST THE COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE IN CONDUCTING AN INDEPENDENT AUDIT OF THE ATLANTA WORKFORCE DEVELOPMENT AGENCY; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta administers special job and job training programs under contract to the Atlanta Workforce Development Agency (“AWDA”); and

**WHEREAS**, the Atlanta Workforce Development Agency’s primary purpose is to serve the residents of Atlanta by providing employment, job training, career development, job readiness, job placement and other supportive services mandated under the Federal Workforce Investment Act (WIA) of 1998; and

**WHEREAS**, the Community Development/Human Resources Committee, which has purview over the Atlanta Workforce Development Agency, is desirous of engaging the City Auditor to conduct an independent audit of AWDA; and

**WHEREAS**, the scope of the audit shall include but not limited to the following items:

1. Measure the effectiveness and efficiency of AWDA operation.
2. Evaluate the process AWDA uses to prepare, support, train, and hire job seekers. Who are they servicing? What is their process? And how are they doing?
3. Review and evaluate AWDA programs such as Local Dislocated Worker Program, Summer Youth Work Program, Adult Program, and AHA Catalyst Program.
4. Verify the number of visitors to AWDA per day/week? How many people are trained? How many people get jobs? How many of those that are trained get jobs?
5. Check the number of jobs created for residents in each of the council districts.
6. Review state program and any reviews/audits done.
7. Determine missed opportunities for grant funding if there are any.
8. Measure promotion mechanisms, job fairs, and overall outreach effectiveness.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, as follows:

**SECTION 1:** That the City of Atlanta Audit Committee is hereby requested to authorize the City Auditor to conduct an Independent Audit of the Atlanta Workforce Development Agency (“AWDA”).

**SECTION 2:** That all resolutions and parts of resolutions in conflict herewith are hereby repealed to the extent of the conflict.
