**A RESOLUTION AUTHORIZING THE REEMPLOYMENT OF JAMALA NEWTON-DANIELS, AS A LEGAL PROGRAM ASSISTANT IN THE DEPARTMENT OF THE OFFICE OF THE CITY SOLICITOR 1001 (GENERAL FUND) 260101 (OFFICE OF THE CITY SOLICITOR) 5111001 (REGULAR SALARIES) 2650000 (MUNICIPAL COURTS) AT SALARY GRADE 13, \$33,396.77 PURSUANT TO §3-505(C) OF THE CHARTER OF THE CITY OF ATLANTA; AND FOR OTHER PURPOSES**

WHEREAS, the Office of the City Solicitor requires administrative and case management performed on all cases prior to prosecution; and

WHEREAS, the Office of the City Solicitor has the need to determine what evidence and/or documentation are needed for trial, and to ensure all necessary evidence and/or documentation needed for trial is obtained in the case prior to prosecution; and

WHEREAS, the Office of the City Solicitor FY2011 budget funded a Legal Program Assistant position; and

WHEREAS, Section 3-505 authorizes that the City of Atlanta may reemploy a retiree which shall not exceed 520 business days, for the purpose of availing the City of particularized skills possessed by said retiree; and

WHEREAS, Section 3-505 (c) of the City Charter further provides that during the period of reemployment the retiree shall not acquire any civil service rights or any further pension rights, and shall not be required to make contributions to the pension fund; and

WHEREAS, Jamala Newton-Daniels previously employed as a Legal Program Assistant, is available for re-hiring for services requiring expertise in prosecution; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows;

**Section 1:** That the Office of the City Solicitor of the City of Atlanta is authorized to re-employ Jamala Newton-Daniels, Legal Program Assistant, as a full-time employee with City of Atlanta, at salary grade 13, \$33,396.77 as provided under §3-505 (c) of the Charter of the City of Atlanta, to be charged and paid from 1001.260101.5111001.265000.

**Section 2:** That all resolution and parts of resolutions in conflict with this resolution are hereby repealed.
