A RESOLUTION AUTHORIZING THE MUNICIPAL CLERK TO PLACE A PUBLIC ADVERTISEMENT IN A NEWSPAPER OF GENERAL CIRCULATION, DEPICTING THE TAX DIGEST MILLAGE RATE, TAX LEVY AND OTHER INFORMATION REQUIRED PURSUANT TO SECTIONS 48-5-32 AND 48-5-32.1 OF THE OFFICIAL CODE OF GEORGIA ANNOTATED; AND FOR OTHER PURPOSES.

WHEREAS, Chapter 3, Section 6-302 of the Charter of the City of Atlanta (“City Charter”) requires the governing body of the City of Atlanta (the “City”) to adopt by ordinance an annual budget for the ensuing fiscal year, not later than June , preceding the commencement of the fiscal year; and

WHEREAS, Chapter 3, Section 6-302 of the City Charter and the 1937 Budget Law, as amended, require that the total appropriation for any fund shall not exceed the estimated fund balance, reserves, and revenues constituting the fund availability of such fund; and

WHEREAS, Chapter 3, Section 6-301 of the City Charter requires the Budget Commission to annually prepare and file with the governing body for submission, to the Mayor, the budget revenue anticipations for the City; and

WHEREAS, the budget revenue anticipations submitted by the Budget Commission cannot be altered or changed by the governing body; and

WHEREAS, the governing body of the City must adopt a millage rate ordinance levying ad valorem taxes on all taxable property within the City, consistent with the Budget Commission budget revenue anticipations, such that an annual balanced budget can be adopted; and

WHEREAS, Section 48-5-32 of the Official Code of Georgia Annotated (“O.C.G.A.”) requires that a report be published in a newspaper of general circulation throughout the county at least two weeks prior to the establishment by each levying authority of the millage rates for ad valorem taxes for the current calendar year; and

WHEREAS, OCGA §48-5-32.1 (c) (2) further provides that when the levying authority proposes to establish a general maintenance and operational millage rate that would require increases beyond the roll-back rate, the levying authority must advertise its intent to do so; and

WHEREAS, the City will prepare a public advertisement, based on the current Tax Digest information received, to be advertised in a paper of general circulation and posted on the City’s website, and will prepare millage rate ordinances to be adopted by City Council in accordance with the provisions of O.C.G.A. 48-5-32 and 48-5-32.1 (c)(2).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Municipal Clerk be and is hereby authorized and directed to place a public advertisement in a paper or papers of general circulation, depicting the tax digest, millage



rate, ad valorem taxes and other information as required by O.C.G.A. §48-5-32.1 and §48-5-32.1 (c) (2).

BE IT FURTHER RESOLVED that the public advertisement shall be in prominent location in such newspaper and shall not be included with legal advertisements.

BE IT FURTHER RESOLVED that the public advertisement will also be posted on the City's website.

BE IT FINALLY RESOLVED that the above mentioned information shall be broadcast on City Cable TV Channel.
