FC-5783(F); PURSUANT TO SECTION 2-1601 OF THE PROCUREMENT AND REAL ESTATE CODE OF THE CITY OF ATLANTA, UTILIZING THE ATLANTA INDEPENDENT SCHOOL SYSTEM CONTRACTS, FOR THE PURPOSE OF PROVIDING SECURITY SYSTEMS SERVICES ON BEHALF OF THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS, IN AN AMOUNT NOT TO EXCEED ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000.00) PER YEAR WITH ALL CONTRACTED WORK BEING CHARGED TO AND PAID FROM: 7701 (TRUST FUND) 140364 (RECREATION CTR OPERATIONS) 5212001 (CONSULTING/PROFESSIONAL) 6190000 (SPECIAL FACILITIES) 600384 (CENTERS OF HOPE) 69999 (FUNDING SOURCE FOR NON CA); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) owns, operates and manages a number of recreation centers, pool facilities and spray grounds, cultural facilities, outdoor athletic facilities and lighting systems (collectively the “Facilities”) to the benefit of residents and visitors; and

WHEREAS, the Facilities must be protected against theft and vandalism for the benefit of the citizens of Atlanta and the City; and

WHEREAS, the Commissioner of the Department of Parks, Recreation and Cultural Affairs (“DPRCA”) and the Chief Procurement Officer have identified agreements between the Atlanta Independent School System (“AISS”) and six vendors as a source for a cooperative purchase of security systems services; and

WHEREAS, pursuant to § 2-1602 of the City of Atlanta Code of Ordinances, the Chief Procurement Officer may procure supplies, services or construction items through contracts established by a public procurement unit where such contracts and contractors substantially meet the requirements of Article X of the Atlanta City Code of Ordinances; and

WHEREAS, AISS competitively procured the agreements with the vendors in a manner consistent with the City of Atlanta Code of Ordinances; and

WHEREAS, the Commissioner of DPRCA and the Chief Procurement Officer recommend utilizing the AISS agreements with AFA Southeast, Inc., Carter Brothers, LLC., Convergent Technologies, LLC., Onepath Systems, LLC., DH Pace Systems



Integration, and PHB Security Services, LLC., for the purpose of providing security systems services at the Facilities for an initial term of one (1) year with a one (1) year renewal option at the City's sole discretion in an amount not to exceed One Hundred Fifty Thousand (\$150,000.00) per year.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor, or his designee, on behalf of the City is authorized to enter into cooperative purchasing agreements with AFA Southeast, Inc. for FC-5783(A); Carter Brothers, LLC for FC-5783(B); Convergent Technologies, LLC. for FC-5783(C); Onepath Systems, LLC. for FC-5783(D); DH Pace Systems Integration for FC-5783(E); and PHB Security Services, LLC. for FC-5783(F), to provide security systems services at the Facilities in an amount not to exceed One Hundred Fifty Thousand (\$150,000.00) per year.

BE IT FURTHER RESOLVED, that the agreements shall be for an initial term of one (1) year with a one (1) year renewal option at the City's sole discretion.

BE IT FURTHER RESOLVED, that all contracted work will be charged to and paid from: 7701 (Trust Fund) 140364 (Recreation Ctr Operations) 5212001 (Consulting/Professional) 6190000 (Special Facilities) 600384 (Centers of Hope) 69999 (Funding Source for Non CA).

BE IT FURTHER RESOLVED, that the Chief Procurement Officer in consultation with the City Attorney is directed to prepare an appropriate documents for execution by the Mayor.

BE IT FINALLY RESOLVED, that the agreements will not become binding on the City, and the City will incur no obligation or liability under them until they have been approved by the City Attorney as to form, executed by the Mayor, attested to by the Municipal Clerk and delivered to AFA Southeast, Inc., Carter Brothers, LLC., Convergent Technologies, LLC., Onepath Systems, LLC., DH Pace Systems Integration, and PHB Security Services, LLC.
