**A RESOLUTION AUTHORIZING THE REEMPLOYMENT OF CITY RETIREE MR. REGINALD GRANT AS A LEGISLATIVE RESEARCH AND POLICY ANALYST FOR THE ATLANTA CITY COUNCIL, PURSUANT TO SECTION 3-505 (C) OF THE CHARTER OF THE CITY OF ATLANTA, GEORGIA; AND FOR OTHER PURPOSES..**

**WHEREAS**, Mr. Grant retired in good standing, having served the City for over 17 years in numerous capacities including stints as the Director of Financial Analysis and Deputy Chief Financial Officer; and

**WHEREAS**, the Atlanta City Council will be in need of Research and Policy Analysis staffing assistance for the Finance/Executive Committee and Transportation Committee for a period from March through June 2013; and

**WHEREAS**, Mr. Grant's previous experience with the City gives him particularized research skills needed by the Atlanta City Council; and

**WHEREAS**, Section 3-505 (c) of the Charter of the City of Atlanta authorizes that the City of Atlanta may reemploy a retiree for any single period of time, or any several periods of time, which shall not exceed 520 business days, whether continuously or in separate days of employment, for the purpose of availing the City of some particularized skill possessed by said retiree; and

**WHEREAS**, the Atlanta City Council desires to retain the services of Mr. Grant and his specialized skills in a position of Research and Policy Analyst; and

**WHEREAS**, the Atlanta City Council and Mr. Grant have mutually agreed to his reemployment as a Research and Policy Analyst.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that:**

**SECTION 1:** The Atlanta City Council is authorized to reemploy Mr. Reginald O. Grant as a Research and Policy Analyst with the Atlanta City Council in an extra-help capacity without benefits, for a period not to exceed one hundred and twenty (120) days at a rate of pay of forty two dollars and fifteen cents (\$42.15) per hour, as authorized by Section 3-505 (c) of the Charter of the City of Atlanta. Said reemployment will begin on Monday, March 12, 2012.

**SECTION 2:** All ordinances and parts of ordinances in conflict herewith are hereby repealed.
