**A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXECUTE A SOLE SOURCE AGREEMENT CONTRACT NUMBER SS-5726-PL WITH NEC CORPORATION OF AMERICA, FOR THE PURCHASE OF MAINTENANCE AND SUPPORT SERVICES RELATED TO THE AUTOMATED FINGERPRINT IDENTIFICATION SYSTEM HARDWARE AND SOFTWARE ON BEHALF OF THE ATLANTA POLICE DEPARTMENT, FOR AN INITIAL TERM OF THREE (3) YEARS BEGINNING 1 APRIL 2012 AND ENDING 31 MARCH 2015, WITH TWO (2) ONE-YEAR RENEWAL OPTIONS IN AN AMOUNT NOT TO EXCEED TWO HUNDRED THIRTY-NINE THOUSAND ONE HUNDRED THIRTY-THREE DOLLARS AND NO CENTS (\$239,133.00) PER YEAR, FOR A TOTAL CONTRACT AMOUNT NOT TO EXCEED SEVEN HUNDRED SEVENTEEN THOUSAND THREE HUNDRED NINETY-NINE DOLLARS AND NO CENTS (\$717,399.00); ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM 1001 (GENERAL FUND), 240204 (APD POLICE RECORDS & IDENTIFICATION), 5222002 (REPAIR & MAINTENANCE-EQUIPMENT), 3224000 (RECORDS AND IDENTIFICATION); AND FOR OTHER PURPOSES.**

**WHEREAS**, the Atlanta Police Department (the “Department”) has used the Automated Fingerprint Identification System (“AFIS”) to accurately and positively determine the identity of individuals for over sixteen (16) years; and

**WHEREAS**, the NEC Corporation of America (“NEC”) has been the sole provider of hardware, software, and maintenance services related to the AFIS since such system was obtained; and

**WHEREAS**, the accurate and positive identification of individuals is critical to the Department’s ongoing investigation of crimes and in its ongoing search for dangerous criminals wanted under valid warrants; and

**WHEREAS**, the Chief Procurement Officer has designated NEC as a sole source for the maintenance and support services related to the AFIS hardware and software pursuant to Section 2-1191 of the City of Atlanta Code of Ordinances; and



**WHEREAS**, the Chief of Police and the Chief Procurement Officer recommend the Mayor execute a Sole Source Agreement contract number SS-5726-PL with NEC for maintenance and support services related to the AFIS hardware and software on behalf of the Department for an initial term of three (3) years beginning 1 April 2012 and ending 31 March 2015, with two (2) one-year renewal options, in an amount not to exceed Two Hundred Thirty-Nine Thousand One Hundred Thirty-Three Dollars And No Cents (\$239,133.00) per year, for a total contract amount not to exceed Seven Hundred Seventeen Thousand Three Hundred Ninety-Nine Dollars and No Cents (\$717,399.00).

**NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the Mayor is authorized to enter into a Sole Source Agreement contract number SS-5726-PL with NEC for maintenance and support services related to the AFIS hardware and software on behalf of the Department, in an amount not to exceed Two Hundred Thirty-Nine Thousand One Hundred Thirty-Three Dollars And No Cents (\$239,133.00) per year, for a total contract amount not to exceed Seven Hundred Seventeen Thousand Three Hundred Ninety-Nine Dollars and No Cents (\$717,399.00).

**BE IT FURTHER RESOLVED**, that the base term will be for three (3) years beginning 1 April 2012 through 31 March 2015 with two (2) one-year renewal options that can be terminated by either party upon ninety (90) days written notice.

**BE IT FURTHER RESOLVED**, that all contracted work will be charged to and paid from 1001 (General Fund), 240204 (APD Police Records & Identification), 5222002 (Repair & Maintenance-Equipment), 3224000 (Records and Identification).

**BE IT FURTHER RESOLVED**, that the Chief Procurement Officer, in consultation with the City Attorney or her designee is directed to prepare the appropriate agreement for execution by the Mayor.

**BE IT FINALLY RESOLVED**, that the agreement will not become binding upon the City of Atlanta ("City"), and the City shall incur no liability upon same until the contract has been approved by the City Attorney or her designee as to form, executed by the Mayor, attested to by the Municipal Clerk, and delivered to NEC.
