


A RESOLUTION AUTHORIZING FULTON COUNTY BOARD OF REGISTRATION AND ELECTIONS TO USE THE ADAMSVILLE RECREATION CENTER AS AN EARLY/ADVANCE VOTING LOCATION FOR THE GENERAL & SPECIAL ELECTION TO BE HELD ON NOVEMBER 6, 2012 AND IF NECESSARY AND PRACTICABLE, FOR ANY RUN-OFF ELECTIONS ASSOCIATED THEREWITH; AND FOR OTHER PURPOSES.

WHEREAS, during recently held elections, City of Atlanta voters have become accustomed to vote during Early and /or Advance Voting periods at the Adamsville Recreation Center; and

WHEREAS, the Fulton County Board of Registration and Elections has requested use of the Adamsville Recreation Center as a voting location for the General & Special Election to be held on November 6, 2012 and if necessary and practicable, for any run-off elections associated therewith ; and

WHEREAS, the mayor and council of the City of Atlanta believe that it is in the best interest of the City's electorate to maintain their option to vote at the Adamsville Recreation Center.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1. That the Municipal Clerk/ Election Superintendent is hereby directed to notify the Fulton County Board of Registration and Elections, of the City of Atlanta's authorization of the use of Adamsville Recreation Center as an Early/Advance Voting location for the General & Special Election to be held on November 6, 2012 and if necessary and practicable, for any run-off elections associated therewith.

Section 2. That the Commissioner or Acting Commissioner of the Department of Parks Recreation and Cultural Affairs is hereby directed to work with the Fulton County Board of Registration and Elections as is necessary to facilitate the use of Adamsville Recreation Center as an Early/Advance Voting location for the General & Special Election to be held on November 6, 2012 and if necessary and practicable, for any run-off elections associated therewith.



Section 3. That there shall be no rental fees associated with the use of Adamsville Recreation Center as an Early/Advance Voting location for the General & Special Election to be held on November 6, 2012 and if necessary and practicable, for any run-off elections associated therewith, provided however, that Fulton County shall pay any reasonable and practicable fees assessed by the Department of Parks Recreation and Cultural Affairs for cleaning, custodial and additional staffing services required because of said election(s) and as authorized by state law.

Section 4. That all resolutions or parts of resolutions in conflict herewith are hereby rescinded.
