**A RESOLUTION BY FINANCE EXECUTIVE COMMITTEE AUTHORIZING THE MAYOR OR HIS DESIGNEE TO WAIVE THE APPLICATION OF THE SOLE SOURCE SELECTION METHODS PRESCRIBED IN THE ATLANTA CITY CODE, ARTICLE X, THE PROCUREMENT AND REAL ESTATE CODE, AND AUTHORIZING THE MAYOR OR HIS DESIGNEE TO CONTINUE ITS MAINTENANCE AGREEMENT WITH RICOH AMERICAS CORPORATION AND MILNER INC, PURSUANT TO THE STATE OF GEORGIA CONTRACT GS-35F-0085U, FOR COPIER MAINTENANCE AND SUPPORT SYSTEMS, ON BEHALF OF THE MUNICIPAL COURT OF ATLANTA FOR A PERIOD OF ONE (1) YEAR IN FY12 AND REMIT PAYMENT THERETO IN AN AMOUNT NOT TO EXCEED TWENTY-SEVEN THOUSAND DOLLARS (\$27,000); ALL COSTS TO BE CHARGED TO: FUND, DEPARTMENT, ACCOUNT, AND FUNCTION ACTIVITY: 1001 (GENERAL FUND), 190101 (MUNICIPAL COURT OPERATIONS), 5212001 (CONSULTANT PROFESSIONAL SERVICES), 2650000 (MUNICIPAL COURTS); AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta ("City") Municipal Court desires to be exempt from the Sole Source Selection methods prescribed in Atlanta City Code, Article X and be authorized to continue its contract with Ricoh Americas Corporation and Milner Inc. and be authorized to remit payment to Ricoh Americas Corporation and Milner Inc. pursuant to said contract in accordance with GS-35F-0085U, for the purpose of purchasing copier maintenance and support systems which entails staples, toner and allotted copies/per quarter for 35 copiers; and

**WHEREAS**, Ricoh Americas Corporation and Milner Inc. is experienced in the support of copier maintenance and support systems; and

**WHEREAS**, Ricoh Americas Corporation and Milner Inc. has provided adequate copier maintenance and support systems and can continue to provide ongoing copier maintenance and support systems.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES** that the Mayor or his designee be and are hereby authorized to be exempt from the City's Sole Source Selection methods prescribed in Article X of the Atlanta City Code and are authorized to continue its copier maintenance and support systems agreement with Ricoh Americas Corporation and Milner Inc, pursuant to GS-35F-0085U, for copier maintenance and support systems, for a period of one (1) year in FY12, in an amount not to exceed twenty-seven thousand dollars (\$27,000).

**BE IT FURTHER RESOLVED**, that the City Attorney or her/his designee be and is directed to prepare the Agreement for execution by the Mayor, and the Agreement shall be approved by the City Attorney or her/his designee as to form.



**BE IT FURTHER RESOLVED**, that the Agreement shall not become binding upon the City, and the City shall incur no obligation or liability hereunder until the same has been signed by the Mayor or her/his designee and delivered to Milner Inc.

**BE IT FINALLY RESOLVED**, that all contracted work shall be charged to: 1001 (General Fund), 190101 (Municipal Court Operations), 5212001 (Consultant/Professional Services), 2650000 (Municipal Courts).
