A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO PARTICIPATE WITH THE INMAN PARK NEIGHBORHOOD ASSOCIATION IN MAKING CERTAIN IMPROVEMENTS TO SPRINGVALE PARK BY PROVIDING AN AMOUNT NOT TO EXCEED TWENTY THOUSAND DOLLARS (\$20,000.00) TOWARD CONSTRUCTION OF A PLAYGROUND, WHERE ALL FUNDS SHALL BE CHARGED TO AND PAID FROM FUND, DEPARTMENT, ORGANIZATION AND ACCOUNT NUMBERS: 3501 (PARK IMPROVEMENT FUND) 140106 (PRC PARKS DESIGN) 5222003 (REPAIR & MAINTENANCE-OTHER) 6220000 (PARK AREAS); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) owns Springvale Park, located near the intersection of Euclid Ave., N.E. and Waverly Way N.E. (the “Park”) in Council District 2; and

WHEREAS, the Inman Park Neighborhood Association (“IPNA”) has been working to improve the Park, including a Park Pride Vision Plan, completion of a formal master planning, park workdays, and volunteer opportunities, and

WHEREAS, the Park’s playground equipment is more than 15 years old and is approaching obsolescence and has minimal play opportunities for children; and

WHEREAS, according to the census, Inman Park's population has nearly doubled since 1990, and many of the new residents are families with children; and

WHEREAS, IPNA is committed to making significant improvements to the Park through cleanups, financial donations and a playground that provides play opportunities to children of many ages and abilities (the “Project”); and

WHEREAS, IPNA has as of December 2011 raised ten thousand dollars (\$10,000) cash and in-kind donations, has three fundraising events planned in the spring of 2012, has leveraged grants through Park Pride and continues to advocate and fundraise with local residents and businesses for the Project; and

WHEREAS, the Department of Parks, Recreation and Cultural Affairs desires to participate in the Project by providing funds in an amount not to exceed Twenty Thousand Dollars (\$20,000.00); and

WHEREAS, IPNA will complete the Project through Park Pride, the organization charged with acting as a fiduciary agent for donated funds dedicated to park improvement, and coordinating volunteer services citywide for park improvement, beautification and maintenance; and

WHEREAS, the City is appreciative of the contributions of the IPNA and Park Pride and finds that it is in the City’s best interest to assist IPNA in completing the Project.



THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor or his designee, on behalf of the City, is hereby authorized to pay an amount not to exceed Twenty Thousand Dollars (\$20,000.00) to Park Pride on behalf of IPNA for the Project at the Park.

BE IT FURTHER RESOLVED, that the City hereby accepts the contributions of the IPNA at the Park.

BE IT FINALLY RESOLVED, that all funds shall be charged to and paid from the following Fund, Department, Organization and Account Number: 3501 (Park Improvement Fund) 140106 (PRC Parks Design) 5222003(Repair & Maintenance-Other) 6220000 (Park Areas).
