OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta and other major cities are experiencing a proliferation of litter, waste and scrap tires in their neighborhoods; and

**WHEREAS**, neighborhoods are seeking solutions and assistances from their elected officials as to how they can maintain their neighborhoods' character and viability; and

**WHEREAS**, the City of Atlanta in conjunction with Keep Atlanta Beautiful are planning to hold a Tire Roundup/ Amnesty Day on Saturday, April 28, 2012; and

**WHEREAS**, this event is expected to collect fifteen thousand (15,000) tires for processing and recycling; and

**WHEREAS**, the Liberty Tire Recycling, LLC has offered to support the city's effort by providing seven (7) vehicles and thirteen (13) employees to pickup and prepare the tires for recycling. The cost of the labor, material and processing is estimated at \$18,750.00; and

**WHEREAS**, the City of Atlanta and its neighborhoods will be greatly enhanced by eliminating scrap tires from illegal dump sites which poses public health issues from standing water which breeds mosquitoes.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA** as follows:

**SECTION 1:** That Mayor or his designee is authorized to accept the use of seven (7) vehicles and thirteen (13) employees on Saturday, April 28, 2012 for the Tire Roundup/ Amnesty Day at a cost estimated to be an amount not to exceed \$18,750.00 from Liberty Tire Recycling, LLC.

**SECTION 2:** That all resolutions and parts of resolutions in conflict herewith are hereby waived for this instance only.
