A SUBSTITUTE ORDINANCE

**AN ORDINANCE AUTHORIZING THE MAYOR TO ACCEPT AND SIGN A GRANT AGREEMENT FOR THE LAKEWOOD ACTIVITY CENTER LIVABLE CENTERS INITIATIVE AWARDED BY THE ATLANTA REGIONAL COMMISSION IN THE AMOUNT OF \$124,000; AMENDING THE 2012 (INTERGOVERNMENTAL GRANT FUND) BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF ONE HUNDRED AND TWENTY THOUSAND DOLLARS AND NO CENTS (\$124,000.00); AND AMENDING THE 2012 INTERGOVERNMENTAL GRANT FUND BUDGET BY \$60,000 IN MATCH FUNDS COMMITTED TO THIS PROJECT; AND FOR OTHER PURPOSES.**

**WHEREAS**, Resolution 11-R-1692 authorized the Mayor to submit a Livable Centers Initiative (LCI) Grant application to the Atlanta Regional Commission under its 2012 competitive grant program; and

**WHEREAS**, the Bureau of Planning and Invest Atlanta prepared and submitted a grant application on behalf of the City for a planning study for the Lakewood Activity Center and the surrounding neighborhoods, and;

**WHEREAS**, matching funds for this grant will be provided by Invest Atlanta, the District 1 and District 12 Council Members and by the Screen Gems Studio in an aggregate amount of \$60,000.; and

**WHEREAS**, the Atlanta Regional Commission has awarded the City a 2012 LCI Grant award in the amount of \$124,000.00.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS:**

**Section 1.** That the Mayor is hereby authorized to sign a grant agreement with the Atlanta Regional Commission for the Lakewood Activity Center LCI project in an amount not to exceed \$124,000.00.

**Section 2.** That the Mayor is hereby authorized to accept the matching funds for this grant that will be provided by Invest Atlanta, the District 1 and District 12 Council Members and by the Screen Gems Studio in an aggregate amount of \$60,000 amending the 2012 Intergovernmental Budget.

**Section 3.** That the 2012 Intergovernmental Grant Fund be and is hereby amended as follows:
