AN ORDINANCE TO CODIFY, AT SECTION 150-244 OF THE CODE OF ORDINANCES OF THE CITY OF ATLANTA, ORDINANCE NUMBER 98-O-0204, ADOPTED, FEBRUARY 16, 1998 AND APPROVED, MARCH 2, 1998, PERTAINING TO THE PROHIBITION OF COMMERCIAL "CUT-THROUGH" TRUCK TRAFFIC ON MOORES MILL ROAD, WEST OF I-75; AND FOR OTHER PURPOSES.

Whereas, Ordinance Number 98-O-0204, adopted, February 16, 1998 and approved, March 2, 1998, pertaining to the prohibition of commercial "cut-through" truck traffic on Moores Mill Road, west of I-75, was not codified in that it bore no reference to amending any part, section or provision of the City Code; and

Whereas, said ordinance should be a part of and incorporated into the Code of Ordinances of the City of Atlanta, Georgia.

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: Ordinance Number 98-O-0204, adopted, February 16, 1998 and approved, March 2, 1998, pertaining to the prohibition of commercial "cut-through" truck traffic on Moores Mill Road, west of I-75, which provides as follows:

- (a) All vehicles exceeding 30 feet in length, 18 tons in weigh or having more than six (6) wheels (excluding buses) shall be prohibited front traveling on Moores Mill Road, west of 1-75, unless a vehicle fitting that description is specifically having a point of destination within the residential neighborhood with a manifest to prove it.
- (b) A fine of \$500.00 shall be established for violators of this prohibition.
- (c) The Department of Public Works/Transportation Services shall post prominent signs at both ends of the western segment of Moores Mill Road, with the signs to read:
 - "NO TRUCKS" at the top of the sign.
 - The center of the sign depicting the international symbol for prohibiting truck traffic (which is a picture of a truck with a circle drawn around it and a line drawn through it).
 - Over 30 ft. long, over 18 tons, or having more than 6 wheels" at the bottom of the sign.
 - "\$500 FINE FOR VIOLATORS" being the last statement on the sign.



IS HEREBY CODIFIED as Section 150-244 of the Code of Ordinances of the City of Atlanta, Georgia, and be captioned: " Commercial 'cut-through' truck traffic prohibited on Moores Mill Road, west of I-75".

AS CODIFIED, said Code section shall become a part of "Chapter150 – TRAFFIC AND VEHICLES, ARTICLE VI. – VEHICLE SIZE, WEIGHT AND LOAD".

Section 2: To the extent that any ordinance is in conflict herewith, this ordinance shall control.
