A RESOLUTION AUTHORIZING THE MAYOR ON BEHALF OF THE CITY OF ATLANTA TO EXECUTE FC-5684 CLEAN AND CLOSE CONTRACTORS, WITH CTC CONSTRUCTION, LLC FC-5684 RESURGENCE DEMOLITION & ENVIRONMENTAL, INC. FC-5684 AND HOBGOOD CONSTRUCTION COMPANY, INC. FC-5684, TO PROVIDE CITYWIDE CLEAN AND CLOSE SERVICES IN CONNECTION WITH DEMOLITION OF ABANDONED STRUCTURES ON BEHALF OF THE DEPARTMENT OF POLICE, OFFICE OF CODE COMPLIANCE IN AN AMOUNT NOT TO EXCEED FIVE HUNDRED THOUSAND DOLLARS AND NO CENTS (\$500,000.00) TOTAL FOR ALL CONTRACTORS, WITH AN INITIAL TERM OF THREE (3) YEARS WITH ONE (1) TWO (2) YEAR RENEWAL OPTION; ALL CONTRACTED WORK TO BE CHARGED TO AND PAID FROM PROJECT FUND FOR THE ATLANTA URBAN REDEVELOPMENT AGENCY TAXABLE RECOVERY ZONE ECONOMIC DEVELOPMENT BONDS, SERIES 2010; AND WESTSIDE TAD PROJECT FUND; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta's (the "City") Department of Police Office of Code Compliance ("Code Compliance") has approximately fifty (50) clean and close demolition orders and approximately one hundred eighty (180) In Rem cases awaiting execution; and

WHEREAS, the City's Department of Procurement did advertise for FC-5684 Clean and Close Contractors for clean and close services in connection with demolition of abandoned City structures on behalf of Code Compliance; and

WHEREAS, qualified contractors submitted proposals for the right to perform clean and close services for the City and three contractors were chosen; and

WHEREAS, after reviewing and evaluating responsive offers the Chief of Police and the Chief Procurement Officer have recommended that contract FC-5684 Clean and Close Contractors, be awarded to CTC Construction, LLC, Resurgence Demolition & Environmental, Inc., and Hobgood Construction Company, Inc., (CTC Construction, LLC, Resurgence Demolition & Environmental, Inc., and Hobgood Construction Company, Inc., collectively referred to as "Contractors") the most responsive offerors, in an amount not to exceed Five Hundred Thousand Dollars and No Cents (\$500,000.00) total for all Contractors; and

WHEREAS, the contracts shall have an initial term of three (3) years with one (1) two (2) year renewal option at the sole discretion of the City; and



WHEREAS, all funds for these contracts shall be paid by Invest Atlanta, the City's redevelopment arm from project funds for the Atlanta Urban Redevelopment Agency Taxable Recovery Zone Economic Development Bonds and the Westside TAD Project Fund.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor, on behalf of the City, is hereby authorized to enter into contract FC-5684 (A), (B) and (C) Clean and Close Contractors for clean and close services in connection with demolition of abandoned City structures with the Contractors in an amount not to exceed Five Hundred Thousand Dollars and No Cents (\$500,000.00) total for all Contractors for an initial term of three (3) years with one (1) two (2) year renewal options at the sole discretion of the City.

BE IT FURTHER RESOLVED, that all contracted work shall be charged to and paid from PROJECT FUND FOR THE ATLANTA URBAN REDEVELOPMENT AGENCY TAXABLE RECOVERY ZONE ECONOMIC DEVELOPMENT BONDS, SERIES 2010; AND WESTSIDE TAD PROJECT FUND.

BE IT FURTHER RESOLVED, that the City Attorney is hereby directed to prepare contracts for execution by the Mayor.

BE IT FINALLY RESOLVED, that the contracts will not become binding upon the City, and the City will incur no obligation or liability under it until it has been approved by the City Attorney as to form, executed by the Mayor, attested to by the Municipal Clerk, and delivered to the Contractors.
