


**A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO PARTICIPATE WITH PARK PRIDE ATLANTA, INC., IN INSTALLING A WATER WELL SYSTEM, *WATER CONSERVATION AND OTHER WATER QUALITY IMPROVEMENTS* AT LORING HEIGHTS PARK, BY PROVIDING AN AMOUNT NOT TO EXCEED THIRTY THOUSAND DOLLARS (\$30,000.00) TOWARD THE PROJECT WHICH SHALL BE CHARGED TO AND PAID FROM: 1001 (GENERAL FUND) 140201 (PRC- PARK MAINTENANCE) 5312101 (UTILITIES, WATER/SEWER) 6210000 (PARKS ADMINISTRATION); AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta (“City”) owns Loring Heights Park, located near the intersection of Loring Drive, N.W. and Garden Lane, N.W. in Council District 6 (the “Park”); and

**WHEREAS**, the Loring Heights Neighborhood Association (“LHNA”) has been working to improve the Park, including completing a master plan, park workdays and volunteer opportunities; and

**WHEREAS**, as part of the Park improvements being proposed, the Department of Parks, Recreation and Cultural Affairs (“DPRCA”) desires to install a water well, water conservation and other water quality improvements at the Park (“Project”); and

**WHEREAS**, this Project will promote water conservation by using ground water to refill the pond which could then be used for irrigation and other purposes; and

**WHEREAS**, DPRCA desires to partner with Park Pride Atlanta, Inc. (“Park Pride”) to provide construction management services for this project; and

**WHEREAS**, Park Pride is a 501(c)(3) non-profit organization dedicated to providing support, administration, planning, design and construction services for City parks and DPRCA; and

**WHEREAS**, the LHNA has raised over Fifty Five Thousand Dollars (\$55,000.00) cash and in-kind donations and has leveraged grants through Park Pride, Kaboom, Google, and the DeFours Foundation toward Park improvements and continue to advocate for additional resources; and

**WHEREAS**, DPRCA desires to participate by providing funds in the amount of Thirty Thousand Dollars (\$30,000.00) to the Project; and



**WHEREAS**, the City is appreciative of the contributions of the LHNA and finds that it is in the City's best interest to assist the LHNA in completing the Project.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES**, that the Mayor or his designee, on behalf of the City, is authorized to pay an amount not to exceed Thirty Thousand Dollars (\$30,000.00) to Park Pride to construction of a water well system, water conservation and other water quality improvements at Loring Heights Park.

**BE IT FURTHER RESOLVED**, that the City accepts the contributions of the Loring Heights Neighborhood Association at the Park.

**BE IT FINALLY RESOLVED**, that all funds shall be charged to the following Fund, Department, Organization and Account Number: 1001 (General Fund) 140201 (PRC-Park Maintenance) 5312101 (Utilities, Water/Sewer) 6210000 (Parks Administration).
